Explanation of Savings Account Disbursements & Deposits - 2nd Quarter of FY03

The Bank of America erroneously debited ANC 6A's saving account in the amount of \$2,326.96 on Dec. 10, 2002. Two more erroneous debits in the amounts of \$1,707.63 & \$889.19 were subtracted in Jan., 2003. Due to these debits, the account also incurred maintenance fees and over draft fees totaling \$25.02.

The account was credited \$4,923.78 (the amount equal to the total of the three erroneous debits) in Feb., 2003. The Bank of America also credited \$25.02 to the account in Mar., 2003, the amount equal for all related fees resulting from these debits.
