## Advisory Neighborhood Commission (ANC) 6A Minutes Miner Elementary School November 9, 2017

**Present:** Commissioners Phil Toomajian (Chair), Marie Claire Brown, Sondra-Phillips-Gilbert, Amber Gove, Patrick Malone, Mike Soderman, Calvin Ward and Stephanie Zimny.

The meeting convened at 7:00 pm.

The minutes for the ANC October 2017 meeting and the agenda for the November 2017 meeting were accepted without changes or objection.

### Community Presentations

#### Dr. Jennifer Smith, Director, DC Department of Forensic Sciences (DFS)

Dr. Smith spoke about mission of the DFS, and the three divisions of the DFS, Forensic Science Laboratory, Public Health Laboratory, and Crime Scene Sciences, which is responsible for evidence collection and preservation. Dr. Smith also mentioned that the DFS is an independent agency and not under the jurisdiction of any law enforcement agency, but that it worked in conjunction with law enforcement agencies as the circumstances dictate. Dr. Smith took questions from Commissioners and the public, and advised that there are unpaid internships with the DFS for interested students and/or trainees in career related professions. Dr. Smith also indicated that the DFS has an ongoing need for scientists as participants on the DFS Science Advisory Board. #### Micah Feigelson, Community Solar Associate, IP Sun Power

Mr. Feigelson gave a brief overview of IP Sun Power's goal to assist DC in reaching its goal of fifty-percent (50%) green energy by 2032. He spoke of a Solar Renewable Credit Program through the City and of a thirty percent (30%) percent federal tax credit for solar use that will end by 2019. In response to questions from the Commissioners, Mr. Feigelson indicated that there are financing programs available for low-income city residents who wish to convert to solar energy.

#### Mr. Sean Moore, DC Department of Transportation (DDOT) Streetcar team

Mr. Moore relayed information about upcoming public hearings regarding the Benning Road and Bridges Transportation Improvements Project and the Frederick Douglas Memorial Bridge Project. Material regarding the dates, times, and location of the hearings were provided to the public at the ANC 6A meeting. Mr. Moore also mentioned the DCReach public safety campaign, to help drivers remember to look over their shoulders before opening their car doors to the traffic side of the street. ### Officer Reports

Chairman Phil Toomajian spoke of the recent death of Ms. Dana Wyckoff, the ANC 6A Community Outreach Committee Chairman, and overall volunteer community stalwart. The Chairman mentioned specifically Ms. Wyckoff's affiliation with the Rosedale Citizens Alliance and the Rosedale Library and Recreation Center. Ms. Wyckoff was also a board member for the Federation of Friends of the DC Public Library among many other community organizations. The Chairman requested a moment of silence in recognition of Ms. Wyckoff, and her efforts in behalf of the community.

Chairman Toomajian also stated that there would be a Metropolitan Police Department (MPD) Sector 2 meeting at the J.O. Wilson school, on November 16, 2017, at 7:00 p.m., and that the Sector Two meetings would be held on the third Thursday of every month. The Chairman mentioned that the Office of Planning was holding a meeting at the Mount Moriah Baptist Church, 1636 East Capitol Street NE on November 18, 2017, at 10:00 am, regarding the proposed Kingman Historic District. He advised that the requested all-way stop sign for Tenth (10<sup>th</sup>) and Massachusetts Avenue NE should be up soon. Finally, the Chair noted that Councilmember Charles Allen's annual Ward 6 Brickie Awards will be held on December 6, 2017.

### Treasurer's Report

Commissioner Stephanie Zimny delivered the Treasurer's Report. The opening balance in the checking account was \$10,921.44, with a forwarding balance of \$5,364.47. There were disbursements of \$450.00 to Irene Dworakowski (Check 1806) for agenda/web master services; \$143.50 to FedEx (Check 1807); \$200.00 to Gail John (Check 1808) for October 2017 minutes; \$899.47 to Miner Elementary School PTO (Check 1809) for picnic tables; and \$3,864.00 to the Hill Rag for renewal (Check 1810); leaving a balance of \$5,556.97, in the checking account and \$13,770.92, including a \$.023 interest deposit in the savings account. A Petty Cash Summary was included in the report showing a forwarding balance of \$25.00. The report was accepted without objection.

The motion passed (8-0).

### **Single Member District Reports**

Commissioner Malone (6A05) advised there has been a decrease of crime activity in his district, and discussed briefly the Ward 6 leaf collection schedule.

Commissioner Sondra Phillips-Gilbert (6A07) advised that the third annual Safe Halloween event for children at the Rosedale Community Center was successful; and said that there were problems with security and trash/littering issues at Monument Academy.

Chairman Toomajian (6A02) mentioned a circulating petition requesting speed bumps for the 400 and 500 blocks of Tenth (10<sup>th</sup>) Street NE, leading to H Street NE, and other traffic issues, as well as ongoing maintenance issues at the Sherwood Recreation Center.

Commissioner Marie-Claire Brown (6A01) spoke about a shooting that occurred on the 1200 block of H Street NE; the traffic problems around the AVEC construction site at Tenth (10<sup>th</sup>) and H Streets NE; resident concerns about activity around K Street NE; and community concerns regarding the residential parking permit issue.

Commissioner Amber Gove (6A04) gave an update on the Maury Elementary School Redevelopment Project; spoke about DDOT approval for the installation of two (2) raised crosswalks at Constitution Avenue and Twelfth (12<sup>th</sup>) Streets NE and Constitution Avenue and Warren Streets NE; as well as DDOT approval for the installation of curb extensions at Fifteenth (15<sup>th</sup>) Street and North Carolina Avenue NE and Fourteenth (14<sup>th</sup>) Street and C Streets NE.

Dear Mayor Bowser:

At a regularly scheduled and properly noticed meeting on November 9, 2017,<sup>1</sup> our Commission voted 8-0 (with 5 Commissioners required for a quorum) to write you to request funding to renovate the outdoor learning and play spaces at Miner Elementary.

Our neighborhood has witnessed the positive benefits of investments in outdoor learning and play spaces and particularly appreciates the role you played funding the most recent success story in Ludlow-Taylor Elementary School’s new playground. We believe thriving neighborhood schools are an important component of thriving communities and safe, quality outdoor learning/play spaces are essential to ensuring a neighborhood school can thrive.

The Commission believes the outdoor campus of Miner has the potential to be transformed into an innovative learning resource to enhance indoor classroom teaching. A brief walking tour of the campus provides evidence of the need for updated structures and a more cohesive design to better utilize the property. We support Miner advocacy to update its playgrounds to ensure students have access to safe, undamaged and upgraded play spaces. The PTO’s engagement of outside partners, including Playworks, OSSE/Cultivate the City DDOE’s RiverSmart Schools, and our ANC6A grants program, demonstrates its dedication to ensure a comprehensive and cohesive approach to the needed improvements.

Miner’s outdoor campus has experienced unfortunate acts of vandalism during non-school hours, impacting students’ access to facilities during the school day. We applaud your efforts to improve security systems and expect that a renovated playspace would come with improved fencing and security that will help ensure it remains available to children year round.

ANC6A is proud of the work accomplished to date at our neighborhood schools to provide safe, engaging outdoor learning spaces. We look forward to working with you to expedite improvement to the Miner Elementary outdoor campus.

**Eliot-Hine Middle School Modernization Project**

Edited 11/22/2017

The Eliot-Hine modernized project is scheduled for comprehensive modernization with construction to begin in 2019. Planning kicked off in 2016 with the development of an educational specification, community engagement meetings, and a feasibility study. The ‘new’ Eliot-Hine Middle School will provide a learning environment that is safe, universally accessible, and comfortable for students.

**Project Timeline**

All modernization projects will have one year of planning and approximately three years of construction. This project is currently in the design phase of planning. Once an architect is selected, the project will move into its next stage of design.

**Scope of Work**

A feasibility study has been completed by Shinberg Levinas architects in Spring 2017. Through this study, Shinberg Levinas worked with the community to define their vision for this project, and map out a program for a 480-student middle school. This enrollment projection of 480 students will ensure that the Eliot-Hine community will be supported as it grows over time. In

addition, Shinberg Levinas determined there will be approximately 15,000 square-feet of excess space after the full modernization project.

### **Swing-Space Plans**

Eliot-Hine will swing 'internally,' meaning that part of the school will be under construction while the school community occupies another part of the building that is not being disturbed by construction.

### **Communication Plan**

Communication regarding this project is shared with the School Improvement Team (SIT) every 8 weeks, and to the Ward 6 community via quarterly community meetings.

- V. New Business
  - A. Traffic safety on 400 block of Tenth (10<sup>th</sup>) Street NE. The discussion was expanded to include the 500 and 600 blocks as well.
    - i. Safety concerns on these blocks include the following:
      1. Speeding, volume, honking, narrowness (the 400 block of Tenth (10<sup>th</sup>) Street NE in particular is very narrow).
      2. Now that there is a light at Maryland Avenue NE, motorists speed up to make it through the light.
    - ii. Possible solutions include (listed in no particular order):
      1. Speed humps, though some were opposed to speed humps because they can cause a lot of noise with cars crashing into and bottoming out on them (as in the 1300 block of F Street NE). Also, the vibrations could cause structural damage to nearby homes.
      2. Raised crosswalks, such as where E Street NE crosses Tenth (10<sup>th</sup>) Street NE just before the traffic light. The District Department of Transportation (DDOT) will not put a four (4) way stop so close to the light.
      3. Making sections of Tenth (10<sup>th</sup>) Street NE one-way since it is so narrow.
      4. Limit sections of Tenth (10<sup>th</sup>) Street NE to local traffic in the morning and evening.
      5. Contact GPS companies and ask them not to send people zig-zagging through the city to avoid traffic lights.
      6. "No trucks" sign at the turn from Maryland Avenue NE onto Tenth (10<sup>th</sup>) Street NE.
      7. Curb bump-outs for the Sherwood Recreation Center parking lot, and the alley opposite, for traffic-calming.
      8. Mirror for coming out of the alley in the 400 block of Tenth (10<sup>th</sup>) Street NE. But DDOT is more likely to take away parking spaces than put in a mirror.
    - iii. Process for moving forward:
      1. ANC Chair Toomajian is ready to move this forward without a complete petition from the neighbors. He thinks DDOT will move forward with a traffic study with a letter from the ANC. The ANC will vote on this at the next meeting on December 14, 2017 and, if it passes, will send a letter to DDOT the next day. Neighbors should bring/email whatever signatures they have collected to Phil no later than December 14, 2017 so that he can attach them to the letter.
      2. When DDOT comes back with a proposal, there will be a 30-day comment period.

- iv. *Motion: Co-chair Sloves offered a motion, seconded by Jeff Fletcher, recommending that the ANC send a letter to DDOT to study traffic-calming measures for the 400, 500, and 600 blocks of Tenth (10<sup>th</sup>) Street NE, including bump-outs, raised crosswalks, and “no through trucks” signs. The motion passed 5-0 including Commissioner Toomajian.*

Dear Director Marootian:

At a regularly scheduled and properly noticed meeting<sup>1</sup> on December 14, 2017, our Commission voted **X-X-X** (with 5 Commissioners required for a quorum) to support traffic calming measures in the above-referenced location.

This stretch of Tenth (10<sup>th</sup>) Street NE has become prone to speeding, making it dangerous for pedestrians, bikers and other drivers. Our ANC has heard testimony indicating this may be due to the lack of traffic calming measures as well as an unusually broad width on the 600 block. Furthermore, the awkward confluence of Maryland Avenue NE, E Street NE and Tenth (10<sup>th</sup>) Street NE creates confusion for drivers and pedestrians.

Our ANC would like to recommend that DDOT investigate the feasibility of various solutions voiced by residents in this area. On the 400 and 500 blocks, installation of speed humps or curb extensions at alley curb-cuts may help to reduce speeding. Additionally, raised crosswalks at the intersections with E Street, F Street and G Street NE would both improve pedestrian safety and help to reduce drivers' speed. Finally, curb bump-outs at E Street NE as well as at alleyway curb-cuts along the 600 block of Tenth (10<sup>th</sup>) Street would help to reduce the roadway width.

We hope one or more of these various solutions, or others you may recommend, can help improve traffic and safety along Tenth (10<sup>th</sup>) Street. Thank you for giving great weight to the recommendation of ANC 6A.
