This is in response to your request concerning the removal of the rush hour restrictions along the H Street Corridor between 3<sup>rd</sup> and 15<sup>th</sup> Streets, N.E.

The District Department of Transportation (DDOT) has begun the process to remove the rush hour restrictions along H Street, N.E., as stated in the above referenced limits. The designs for the pavement markings and sign changes are being finalized.

DDOT will install all the pavement markings and signing changes first before removing the rush hour restrictions. We anticipate starting this work in the middle of May 2005 with the completion of the project on or about June 1, 2005.

Re: Removal of Rush Hour Parking restrictions Notice 05-30-TS

Dear Mr. Fengler,

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction.

Currently, westbound H Street, N.E. has a morning rush hour restriction between the hours of 7:00 to 9:30 a.m. between 14<sup>th</sup> and North Capitol Streets; and an evening rush hour restriction between the hours of 4:00 to 6:30 p.m., Monday-Friday. The H Street Transportation Study, citizens of the community and the Advisory Neighborhood Commission 6B has recommended the removal of the rush hour parking restriction to enhance parking and safety along the H Street corridor. Therefore, the Traffic Services Administration has made an independent determination to remove the installed No Standing or Parking, 7:00 to 9:30 a.m., and 4:00 to 6:30 p.m., Monday-Friday. The rush hour signs will be removed from the north and south sides of H Street, N.E. between 3<sup>rd</sup> and 14<sup>th</sup> Streets.

All comments on this subject matter must be filed in writing, not later than thirty (30) days after the date of this notice, with the District Department of Transportation, Traffic Services Administration, 2000 14<sup>th</sup> Street, N.W., 7<sup>th</sup> Floor, Washington, D.C. 20009.
