Re: Prioritization of alley bordered by 12th St and 13th St between H St and Linden Place, NE

Mr. Reiskin and Mr. Tangherlini,

As the Single Member District Commissioner representing the community immediately surrounding the alley bordered by 12th Street and 13th Street between H Street and Linden Place, NE, I am formally requesting this alley receive immediate consideration for restoration and improvement.

In response to the letter from Mr. Tangherlini on May 5, 2005, regarding the prioritizing alley and streets for restoration and improvement to Advisory Neighborhood Commission 6A (ANC 6A), the Commission unanimously voted on June 9, 2005, to forward a list of high priority recommendations on behalf of the community. This alley was identified as one of the priorities. The ANC 6A letter to Mr. Tangherlini is attached. In addition, at the emergency public safety community meeting held on June 22, 2005, at the Atlas Theater, one of the key recommendations in response to the concerns raised by the community was examine the feasibility of directly initiating restoration and improvement actions for this alley.

Consequently, given the ANC 6A vote earlier this month, and associated "great weight" that transfers, as well as the discussions at the emergency public safety meeting last week, the community's expectation is that improvements to this alley will be scheduled without delay. Accordingly, I am also requesting that the District Department of Transportation provide an update on the status of this request at the next Wylie/Linden Multiple Agency Plan meeting on July 14, 2005, at 6:00pm, located at Miner Elementary School.

At the June 9, 2005, ANC 6A public meeting, and with a quorum present, the Commission unanimously voted to provide the following list that reflects our community's highest priority needs:

- Alley bounded by 11th St, C St, 12th St, and Park St, NE (0110098701).
- Alley bounded by 10th St, Constitution Ave, 11th St, and Mass Ave, NE (0100096501).
- Alley bordered by 12th St and 13th St between H St and Linden Place, NE.
- Alley bounded by 8th St, D St, 9th St, and C St, NE (0080091604).
- Alley bounded by 9th St, C St, 10th St, and Constitution Ave, NE (0090093901).
- Alley bordered by 11th and 12th, D and E, NE running North/South.
- Alley bordered by 12th and 13th, Duncan Place and E, NE.
- Duncan Street, NE between 14th and 15th.
- 12th Street, NE between C and Maryland Ave (3 blocks).
- Duncan Place, NE between 12th and 13th (on the FY 2005 list).
- E Street, NE between 10th and 12th (on the FY 2005 list).
- Pickford Place, NE between F St and G St (on the FY 2005 list).

Thank you for the opportunity to provide input on the District Department of Transportation's proposed list of future locations for alley and local street restorations in our community.
