Residents of Single Member District 6A-02,

As some of you may have heard, the District of Columbia Metropolitan Police Department (MPD) discovered a burning body behind a building on the 1200 Block of Linden Place, NE early Sunday morning. As reported in the Metro section of the Washington Post, the unidentified man was taken to the medical examiner's office, where he was pronounced dead. The officers spotted the fire about 3:00am and MPD is investigating the case as a homicide.

In the wake of this unfortunate incident, I would like to encourage all neighbors to become more involved with H Street renewal and related public safety efforts in the area. While many conditions have been improving, public safety remains a real concern, and there is still much room for improvement. To that end, Old City Capitol Hill Neighborhood Association is hosting a meeting on June 22 at 7:00pm at the Atlas Theater located 1333 H Street, NE. Unfortunately, I have prior a commitment and will not be able to attend. Ms. Kim Tomadjoglou, a resident on Linden Place, has graciously agreed to attend on my behalf. However, I wanted to share some of my observations regarding the activities that surround this alley.

First, that this particular alley was involved is frustrating because it does not accurately reflect the hard work that community members have invested in improving this alley. As many of you know, since March 2005, we have been working with the Mayor's office on a Multi-Agency Plan (MAP) initiative for the area bounded by Wylie Street, Linden Place, 12th Street and 14th Street NE. This MAP initiative brings the city's many resources to bear on a very small, targeted area. The next MAP meeting is scheduled for July 14, 2005, from 6:00pm to 7:00pm at Miner Elementary School. Following this incident, we will be working with the MAP team to explore, among other things, the installation of motion-sensing lights in that part of the Linden Place alley. A description of the MAP is at enclosure one and a sampling of the efforts and progress in the first few months of the MAP are provided at enclosure two. Enclosure three provides a picture of the alley and our request to Mr. Peter Jones, team leader of the MAP, regarding increased lighting.

Second, the continued hard work of MPD and the citizen volunteers of Police Service Area 102 need to be recognized. Last year, we worked with MPD and Councilmember Ambrose to create a single PSA to enable a comprehensive approach to combat crime on the H Street Corridor. As a result, crime is down in PSA 102. In particular, homicides are down from 9 to 2 over a one year period. Enclosure four provides the latest crime statistics for PSA 102. On the third Thursday of the month, PSA 102 meets at Sherwood Recreation Center at 7:00pm to discuss crime and public safety issues. The next meeting is scheduled for July 21, 2005. In addition, ANC 6A holds a monthly Public Safety Committee meeting on the third Wednesday of the month also at the Sherwood Recreation Center. The ANC 6A Public Safety Committee focuses on issues that affect both PSA 102 and PSA 103. The next meeting will be July 20, 2005 at 7:00pm.

Third, our ANC is working with the businesses on H Street to explore opportunities to make the H Street Corridor cleaner and safer. At our next Economic Development and Zoning committee meeting on June 28 at 7:00pm in the Capitol Hill Towers Community Room, we will be providing a public forum for residents and business leaders to discuss the possible implementation of a clean and safe program for H Street similar to the Business Improvement District on 8th Street SE.

In close, we should not minimize the concerns that surround the discovery of this burned body. The purpose of this letter is to let the community know that I will continue to work with MPD, PSA 102, Councilmember Ambrose and the Mayor's office to improve our neighborhood. Tragic events such as this may help bring more of us together, to participate in and contribute to our public life. I strongly encourage attendance at these community meetings, as they provide constant and continued input both to city officials as well as our elected leaders and often offer opportunities for neighbors to engage in specific, concerted efforts to continue to improve our neighborhood.

SUMMARY

The Wylie - Linden MAP was created through collaboration between District of Columbia agencies and residents and businesses located in this community. The geographic boundaries of the MAP are an extension of the Wylie Street Persistent Problem Area (PPA), created in 2002. In response to community

concerns, and with some of the original goals of the Wylie Street PPA accomplished, the Wylie – Linden MAP intends to continue the infrastructure (i.e., "Clean and Safe") improvements of this area.

ISSUES/PROBLEMS:

Below please find a listing of the most prevalent issues/problems endemic to this area and which will be addressed by the Ward 6 Core Team agencies:

- > Criminal activity, including prostitution and drug dealing
- > Illegal Dumping
- > Trash accumulation

- Overgrowth/trash in tree boxes

Thanks for your response below. Perhaps Mr. Lyles could also look into the following 2 cases a block away (1125 H St. NE (on the 12th St. NE side)), which I'm not sure how to approach because they're not an option on the online service request page.

- 1. Dumpster in public space without a permit.
- 2. Trash in public space.

Both have been there for over a week and come from the building at 1121-1125 H St. NE. The boxes are from Family Dollar (1123 H St. NE). The Family Dollar regularly leaves boxes, and occasionally other garbage, on the side for several weeks before they're eventually picked up. No address in the 1100 block of H St. NE or the 700 block of 12th St. NE had a permit to use public space when I checked in May 2005. This is the third time a dumpster has been placed there, and despite 2 prior complaints to DPW, I don't think a citation issued in those cases.

Hello Mr. Luna. I am forwarding your actions to the Core Team's DPW representative, James Lyles, for follow-up. Thank you for placing your request into the system.

Bulk items are fairly difficult to trace. Without "eyes" (video camera or someone conducting surveillance, for instance) constantly monitoring that alley, there's a high probability that illegal dumping will continue. Erecting movement sensitive lights will help to dissuade would-be dumpers. Perhaps at July's meeting at Miner the group can discuss creative ways of establishing surveillance that would not be dependent upon stretched District \$\$\$.




It's great to see that AutoZone has enlisted MPD to enforce its private parking restrictions on its private lot.

However, the problem for residents, as outlined in the Linden-Wylie multiple agency work plan, is the mechanics that solicit and perform automotive repair on the public streets and sidewalks surrounding the AutoZone. As the calendar and photos I sent Peter Jones demonstrate, they are an almost daily presence. Moreover, AutoZone customers that perform work on the AutoZone

lot--like the maroon Ford Taurus pictured below--are not getting ticketed or asked to leave when they should be.



Thus, they threaten to make the AutoZone a de facto automotive repair facility, which is a land use not permitted in a C2A zone like the 1200 block of H Street NE. Moreover, the customers and mechanics alike dump their automotive waste in the city's and resident's trash cans, yards and drains. These are the real problems that affect the residents who abut the AutoZone.



In short, it's too early for celebration. As the calendar and photographs I forwarded to Peter Jones this morning demonstrate, the street mechanics are an almost daily presence on the public streets and sidewalks of H Street. Thus, the questions remain:

- 1. What do residents need to do to enlist MPD to enforce city regulations--against performing automotive repair on city streets, and perhaps even against impeding public ways and disturbing the peace?
- 2. What do residents need to do to enlist DCRA to enforce business licensing and other regulations against mechanics who operate on public streets and sidewalks?
- 3. What do residents need to do to ensure that AutoZone and its landlord conform their use to

the C2A zoned land uses?

Let's forge a partnership between residents and the MPD, and keep our eye on the ball.

Subject: sanitation enforcement request

Peter,

I submitted request number 952797 for sanitation enforcement against the Popeye's dumpster at 1226 H St. NE. Please note that, although the system somehow changed my entry to "1228 Holbrook St. NE," the correct address is "1226 H St. NE" (I noted that on the request as well). This was the Popeye's dumpster yesterday afternoon:



It smells even worse than it looks.

I'll mention your suggestion about motion-sensitive lighting or other monitoring to see if Kim, CP or another resident in that part of the street is receptive.

On a related matter, one of the guys from Hill Instant Carpet Service (1245 H St. NE) set up a shack next to their store to sell fireworks last year during the week and weekend preceding July 4. Would there be any way of having a DCRA inspector swing by between July 1-4 to cite that kind of activity? I suspect they were operating without a license or permit to erect a structure. Last year, these fireworks guys left their dismantled fireworks shack and other related garbage in the alley when they closed up shop (I submitted the info. to Lt. Butler at MPD with their license plate numbers, but he never followed up). If they don't set up shop again this year, I can notify you in advance so the inspector doesn't make an unnecessary trip.

Subject: DPW-trash inspections

Peter,

I spoke with a DPW representative last month who suggested that DPW inspectors check whether each business (and residence) within the MAP had a licensed trash hauler as required by DC sanitation regulations.

Would you be willing to organize a test run on the businesses on the south side of the 1200 block of H St.? It has only 4 businesses plus the apartment(s) above Moe's (728 13th St.). There is reason to think that one business might be involved in the illegal dumping on this side of the street (Hill Instant Carpet Service at 1245 H St. NE. Occasionally posts a flyer in their window advertising that they perform "other" Home improvement services, and the dumping in the alley frequently contains home improvement debris such as drywall, and they have no dumpster and no observable trash service). My observations suggest there's a 20-60% chance of uncovering something.

Subject: trash in alley

Mr. Jones:

FYI, the garbage (below) was dumped in the alley last week by a white Dodge van with dark tinted windows, sometime on a weekday afternoon. I put in a service request (no. 944710). This will make the 3rd alley cleaning since mid-May.



This is the second time a resident (this time it was me) that someone has spotted a white contractor-type van in connection with dumping at that particular location. Earlier this year, Kim T. down the street noticed a white van leaving debris during the afternoon as well.

The tenant at that location, Hill Instant Carpet Service, often posts a notice in their window offering home improvement services (beyond carpet installation). Notably, they do not have a dumpster. No residents that I have spoken with have seen any trash hauler service their building in the last 1-2 years. The trash in that part of the alley is often construction debris. These coincidences lead some of us to suspect that Hill Instant Carpet Service may have their workers

dump their construction debris in the alley after completing a home improvement project.

In support of this conclusion, in mid-May, I encountered a man and his son with an old brown and tan Chevy truck cleaning up construction debris from this location. I engaged him in conversation, during which the man said that the owner of the business had hired him to take away "their" garbage. The garbage he was hauling away was construction debris--drywall, 5-gallon buckets, and full garbage bags. This debris is the same kind that we have reported in numerous prior service requests.

In short, it might be fruitful to Ms. Alexander or any other DPW trash inspector to focus her investigation on Hill Instant Carpet Service at 1245 H St. NE, given the likelihood that their home improvement contracting business may be the source of the repeated illegal dumping of construction debris.

Since May, DPW has been relatively quick to respond to service requests for alley cleaning.

Subject: food dumpsters in public space

Peter,

There are two additional areas to which I'd like to call your attention for your next walk through for the Wylie-Linden Multiple Agency Work Plan. I know I've raised a lot of problems, but that's H Street right now: a host of problems left in neglect.

A Cluck-U chicken is going up at 1123 H St. NE, according to the construction workers there. Also, a NY Pizza has opened at the 800 block of 13 St., NE within the last year. Thus, neither pre-dates the zoning regulations that I will discuss below. The problem for both of these

establishments, which are arguably fast food or food delivery services, respectively, is the location and visibility of their dumpsters. There's no space behind the 1123 H St. NE (because it has no alley access that I know of), and Family Dollar has been placing its trash along the 12th St. NE side of the building.

According to the zoning regulations (DCMR 11-733.3), fast food establishments must have dumpsters enclosed by gate and brick wall. I don't see how the Cluck-U can comply without gobbling up public space. Likewise, the NY Pizza is already in violation of this zoning regulation and DCMR 11-734.3-.4, which applies to food delivery services. Other regulations, such the ones that apply to food establishments, may apply, I just haven't looked into those yet.

Is it possible to include zoning regulations enforcement in the MAP for these two establishments, so we can be sure that as new businesses come to H St., they comply with existing zoning regulations?



In light of body discovered in the Linden alley in almost the very spot we've had repeated illegal dumping problems, is there an opportunity to request District funding for installation of at least 3-4 motion-sensing (or any other) lights in that part of the Linden Place alley? My sense is that there is a consensus in very strong favor of this step among the residents on that part of the block.



The automatic exposure on this digital photo makes the alley seem a lot brighter than it really is. In reality, everything from the last trash can onward is nearly pitch black. I recommend installing at least two lights along the dark corridor between the buildings about 8'-10' from the ground. The body was found in the dark area on the right (beyond the last clearly visible trashcan).
