Dear Commissioner Fengler:

This letter will confirm that Stephen Baskin and Richard Luna at Kilpatrick Stockton LLP have agreed to provide legal services to Advisory Neighborhood Commission 6A ("ANC 6A"). It is our policy to send an engagement letter summarizing the basis under which we will undertake your representation.

We will assist ANC 6A with the public space hearing and related zoning hearing to deny the use of public space for a gas station at 1400 Maryland Avenue, Northeast. Specifically, we will assist you with legal research and preparation for the administrative hearing before the District of Columbia Department of Transportation Public Space Committee and the hearing before the Board of Zoning Adjustment. We will also assist you in seeking a resolution to the case with the authorized representative of the applicant or authorized representative for that property, if appropriate. However, we will not represent ANC 6A in court proceedings, including appeals of administrative decisions related to this case, unless we agree to do so through a subsequent engagement letter.

We will provide legal services to you on a pro bono basis. We will not charge you for our time and will not charge you for routine office expenses. Depending on the nature of the representation, there may be expenses or costs that we will ask you to pay. We will discuss these with you and obtain your approval before incurring any such expense.

You will identify for us the name and title of the person or persons whom you designate to make decisions for your entity, and you will obtain necessary ANC resolutions for that designation and any others needed pursuant to District of Columbia law and your by-laws.
