and moving into the community. This program would supply 24 hr availability of counseling services for the youth as well as require enrollment in vocational or higher education and participation in 1 service project per month. Martin Pollack Project was hoping to open mid-February 2007 pending funding from Child and Family Services. The location has a certificate of occupancy for a 4-unit apartment building, which may pose a problem as this appears to be a Community Based Residential Facility. Paired with

Commissioner Gladys Mack, the community voted that this be further investigated and that all zoning regulations be met. (More information under ANC6A meeting and Economic Development and Zoning Committee meeting.)

Mr. Wyckoff mentioned the death of the trees on C St NE and the need for their replacement with plans for maintenance. Other community members inquired about street cleaning for 17th St NE.
