Updates!!!

- 1637 E St NE-According to Child and Family Services (CFSA) Martin Pollack Project submitted an incomplete application for the contract and was supposed to submit a complete one in January 2007. Letters sent from the ANC to several agencies, DCRA, Dept of Health, and CFSA. A Certificate of occupancy inspection was conducted by DCRA. We are waiting for the final word.
- Rosedale Recreation Center—Council hearing about FY07 Performance for Department of Parks and Recreation on 2/16/07. Watch for one for FY08 hearings!!
- C St NE: "Brit" (Mr. Wy-

ckoff) updated everybody about the C St NE tree boxes and neighbors discussed concerns with speeding. MPD has been regularly ticketing speeders along this stretch, but something else is needed. Neighbors would like speed humps, raised crosswalks, and speed bumps considered.

MPD needs your help....On Monday 2/26/07 at about 7:20 am, a Raymond O'neill of Hyattsville, MD born 1983 was found in the alley of 1729 D ST NE. Upon arrival, units found a black male in his 20s face down covered in blood in the snow. The victim was found dead and it appears from the tracks in the snow and blood drops that this subject was dumped from a vehicle. The violent crimes unit (VCU) is investigating. There was no call for gunshots in area. The crime camera at 18th and D ST NE will be pulled to see if any part of this crime was captured on tape. 

Recommendations to ANC6A for let-

- Request MPD and DC agencies head up a Multi-agency plan for the Pentacles including Councilmember Mendelson
- Request for Councilmember Mendelson to consider an anti-loitering code similar to the Baltimore Anti-loitering code
- Request procedural change for "papering" in DC
