## Major ANC Joint Initiatives with Council Member Wells for 2006

Our ANC is working in partnership with Council Member Tommy Wells on the following items for this term:

- Expand alcohol single sales moratorium
- 4. Improve nuisance property policies
- 5. Eliminate DC owned vacant property
- 6. Traffic calming of our streets
- 7. Improve public space and parks
- 8. Improve DCRA accountability, function, and transparency
- Improve illegal construction enforcement
- 10. Capitol Hill Historic District expansion
- Improve transportation demand management strategies for new development – see discussion below
- 12. Improve social services

#### **Transportation Demand Management**

This is probably a new topic for many of you. Transportation Demand Management (TDM) is a general term for strategies that result in more efficient use of transportation resources.

Simply put, TDM strategies encourage and promote the spreading of travel trips across multiple modes of travel – driving, transit, walking, and bicycling. As our city and the region continues to grow, it is essential that we plan and encourage alternative travel polices to avoid complete gridlock which will ruin our economy and quality of life. We can not expand the existing roadway system in DC without eliminating parking or bulldozing our buildings.

To illustrate I will give a few examples.

#### Car Sharing

Flexcar and Zipcar are companies that allow its members (\$25 annual fee) to rent a car on an hourly basis (\$8 per hour, gas and insurance included). Each individual car is shared between 10-15 individuals. The benefit to members is it reduces the need to own a car, or more typically a second car which saves up \$2,000 per year on payments, fuel, and insurance. Non members benefit from the presence of fewer cars in the neighborhood as it studies show 25% of shared car members sell a personal vehicle once they join.

#### **Transit**

Our ANC has led the way to encourage DDOT to construct a streetcar on H Street to connect Minnesota Avenue metro station to Union Station. Streetcars can carry more people than the buses and it has been shown that more people are willing to ride a streetcar or metro line than a bus.

Bus service can be encouraged by ensuring cleaner buses, running on time, running convenient schedules, and providing nicer bus stops and access to schedules with easy to read maps.

#### **Shared Parking**

Parking is often the most stressful element for a neighborhood as development occurs. Some portions of our neighborhood are already feeling pressure from visitors to the new bars and theatres on H Street.

The concept of Shared Parking is simple

— it is maximizing existing parking by
encouraging the shared use of existing
parking resources. This occurs all the

time on our residential streets but it rarely occurs at the church, school, condo, and business parking lots. These spaces are reserved for the users of the site which are often only needed for specific times of day or periods of the week.

For example, the parking lot at Miner Elementary is available only for the teachers and guests and it is closed at night and weekends. It would be better for the neighborhood if this lot was available for night time visitor parking, resident parking, and business parking. One possible use would be to allow business owners along H to valet customer cars to this site on Thursday, Friday, and Saturday evenings so that our street parking can be reserved for the residents. The money generated could be utilized to fix the school,

provide traffic calming around the school, or to fund an after school program.

#### Walking

We are blessed to live in a neighborhood with beautiful homes, sidewalks, and tree lined streets.

Walking is an enjoyable way to get around but the experience is affected by poor sidewalks, blocked sidewalks (vehicles parking across sidewalk), driveway frequency, and motorist disrespect for pedestrians at crosswalks.

We also have many angled intersections which can be a hazard to cross and we experience daily frustrations with motorist running or rolling through stop signs, speeding through the neighborhood, or failing to let pedestrians cross the road.

Our ANC is addressing these issues by supporting and encouraging the traffic calming program which will redesign the angled intersections, provide curb extension of sidewalk into the street, and install speed humps or raised crosswalks to slow speeds. We are also working with MPD to enforce ticketing of vehicles parked on sidewalks, speeding motorists, and motorists failing to stop for pedestrians.

#### Trash, Recycling, and Litter Campaign

I often receive complaints about the presence of rats and litter in our streets and alleys. I want to start a partnership with the neighborhood and lead an ANC initiative to improve the quality of our streets and reduce the trash on our streets. The constant presence of litter and graffiti leaves an impression that we don't care about our neighborhood. To reduce littering it is going to take a combined effort between the city government and the residents.

What DPW can do: I am going to work with DPW, the ANC, and Council Member Wells to improve the trash collection process. DPW needs to do a better job of picking up all of the trash when advertised, they can't let it fall out of the truck, they need to drive responsibly, and they need to provide cans to residents when asked for and not run them over in the alleys and leave them scattered in the road after collection. Long term, I would like to see more public trash cans placed on our streets and in our parks. DPW will not place additional trash cans on our streets as long as they are used by area residents who place their household trash in the public cans.

What we can do: Trash is picked up on Monday and Thursday. Trash needs to be placed in a can if left out over night. If bags are placed, they should be put out the morning of pickup. Bags left over night are a primary source of food for rats, mice and other vermin as they can smell the food inside and easily rip open the bags. Opened bags spread litter on our streets and DPW staff will not pick up the debris.

Do not place household trash in public cans. Public trash cans are placed on our streets to reduce litter. When these cans are filled with household trash, there is no room for the candy wrappers, bottles, doggie "poop bags", and fast food items to be disposed of. You can receive a \$75 fine for placing household trash in public cans. If you need a can or if your trash is not picked up, report it at 727-1000 or contact me. If you see illegal dumping, call 911 immediately.

The ANC sent a letter to DPW in March asking them to consider modifying the public trash cans on Maryland Avenue with small tops to prevent the placement of household trash bags. I will keep you posted on the developments of this request.
