Dear Business Owner,

We write to inform you that ANC 6A's Alcohol Beverage Licensing Committee ("ABL" or "ABL Committee") has updated its template settlement agreements for future ABRA licensees in ANC 6A. Most notably, the ABL Committee and ANC 6A have removed the anti-loitering provisions, including the provisions requiring businesses to enforce anti-loitering policies, as well as any provisions requiring signage regarding loitering.

The ANC also intends to cease enforcement of any anti-loitering provisions in prior settlement agreements. This means that the ANC will not petition the ABC Board if individual businesses currently operating under settlement agreements signed prior to 2021 do not enforce anti-loitering policies or post anti-loitering signage. However, businesses may *choose* to enforce their own anti-loitering policies and should continue to contact appropriate public and emergency services should the need arise.

ANC 6A and ANC 6A ABL Committee meetings are always open to the public, and we welcome your feedback. For the duration of the pandemic, ANC 6A and ANC 6A ABL committee meetings are conducted virtually via videoconference at 7:00 pm on the 2nd Thursday and 4th Tuesday of every month, respectively. The next ANC 6A meeting is scheduled for Thursday, April 8, 2021 at 7:00 pm and the next ANC 6A ABL Committee meeting is scheduled for Tuesday, April 27, 2021 at 7:00 pm.
