- Tracks applications for new licenses, license changes, and license renewals for ABRA-licensed establishments within ANC 6A;
- Works with appropriate SMD Commissioner(s) to negotiate and maintain settlement agreements on behalf of the ANC with ABRA-licensed establishments within ANC 6A;
  - Settlement agreements that address noise, safety, and/or trash management are required for each request for a new or renewal ABC license with ABRA.
- Assists Commissioners and community members in addressing concerns pertaining to ABRA-licensed establishments within ANC 6A; and
- As appropriate, represents ANC 6A in ABRA proceedings.

# Proposed Language

# ALCOHOLIC BEVERAGE CANNABIS (ABC) COMMITTEE

The ABC Committee advises the Commission on issues related to the DC government's Alcoholic Beverage and Cannabis Administration (ABCA). The ABC provides the community with the first opportunity to engage in all alcohol license and cannabis issues in ANC 6A. As part of this effort, the Committee:

- Tracks applications for new licenses, license changes, and license renewals for ABCA-licensed establishments within ANC 6A;
- Works with appropriate SMD Commissioner(s) to negotiate and maintain settlement agreements on behalf of the ANC with ABCA-licensed establishments within ANC 6A;
  - $\circ$  Settlement agreements that address noise, safety, and/or trash management are required for each request for a new or renewal ABC license with ABCA.





- In the case where the protest deadline for a Cannabis or alcohol license application, renewal or modification falls before the next regularly scheduled ANC meeting, the Chair of the ANC ABCA Committee or the ANC Chair or Vice-Chair is authorized to automatically request an extension of the protest deadline until a date at least 5 days after the next regularly scheduled ANC meeting. If the extension is not granted, the ANC Chair or Vice-Chair may call a special ANC meeting to consider the application, with preference for allowing at least five days before the protest deadline.
- Assists Commissioners and community members in addressing concerns pertaining to ABCA-licensed establishments within ANC 6A; and
- As appropriate, represents ANC 6A in ABCA proceedings.

# Advisory Neighborhood Commission (ANC) 6A Minutes Zoom Meeting December 12, 2024

**Present:** Commissioners Amber Gove, Chair, Dave Wethington, Roberta Shapiro, Robb Dooling, and Steve Moilanen were present. Commissioner Mike Velasquez was absent.

The meeting convened virtually via Zoom at 7:00 pm.

Chair Amber Gove called the meeting to order and noted the presence of a quorum. The minutes for the ANC November 2024 meeting minutes were accepted and the agenda was accepted by unanimous consent.

The community received meeting notice via listservs, the Hill Rag, ANC website, X and Facebook.

### **Community Presentation**

### Introduction of New ANC 6A Commissioners

The following incoming Commissioners will start in 2025 and introduced themselves:

- Paul Spires (ANC 6A01) is currently the Chair of the Community Outreach Committee and is a native Washingtonian. Mr. Spires lives on the 1100 block of I Street and is hoping to popularize Sunday morning meetups across ANC 6A.
- Jeff Giertz (ANC 6A06) lives on the 1400 block of F Street NE and has been in the neighborhood for ten years. Mr. Giertz is looking forward to continuing to elevate community concerns of crime and transportation and generally hoping to make the neighborhood a better place.
- Stephen Kolb (ANC 6A07) lives on the 200 block of 10<sup>th</sup> Street NE and has lived there for more than 15 years and is hoping to address traffic, noise, and pedestrian and cyclist safety.

# **Officer Reports:**

- The December 2024 Treasurer's report by Commissioner Steve Moilanen reviewed the expenditures accrued in November: \$771.19 for webmaster services and \$250 for notetaking (checks #2135 and #2136, respectively). The opening uncommitted funds available were \$30,629.53. After accounts payable totaling \$4,337.75 the closing available checking balance is \$26,291.78. The savings account opened at \$100.05, gained no interest, and closed at \$100.05, and petty cash remained at \$25. The Treasurer's report was approved by unanimous consent.
- 2. Commissioner Roberta Shapiro moved and Commissioner Dave Wethington seconded the motion that ANC 6A approve the Fiscal Year 2024 4<sup>th</sup> Quarter Report. The motion passed 5-0.
- 3. Commissioner Moilanen moved and Commissioner Gove seconded the motion that ANC 6A renew service agreements for package prep/web services and notetaker for FY2025. The last time the rates were updated was early 2020, and the Commission recommended that Commissioner Moilanen negotiate a reasonable increase as part of the agreement renewal. The motion passed 5-0.

1. Commissioner Wethington moved and Commissioner Shapiro seconded the motion that ANC 6A authorize Commissioners Gove, Dooling, and Wethington to finalize its Annual Report for Fiscal Year 2024. Commissioner Robb Dooling is working on collecting several committees' input for the report.

# **Commission Business**

### Single Member District reports

Commissioner Moilanen (6A07) is grateful to ANC 6A Commissioners for being great colleagues and takes solace in the work of groups such as these in the face of upcoming unease.

Commissioner Robb Dooling (6A06) reported that abandoned vehicles continue to be an issue; several have been removed but then more come in, especially on Linden Court. The Commissioner's advice for incoming Commissioners is to look at the abundant resources and archives on the website, which go back through 2003, when advocating for issues. Commissioner Dooling looks forward to attending Committee meetings and supporting the ANC as a community member.

Commissioner Wethington (6A05) noted that there is a community meeting with DPR and DGS on December 17, 2024 at 6:30 pm at Rosedale Recreation Center about Kingsman Dog Park to kick off the construction phase of the renovation project. There have been notices about sidewalk repairs to brick sidewalks and the Commissioner urges community members to be mindful of 'no parking' signs. The Commissioner praised his fellow Commissioners and committee leaders and members, noting that their knowledge, as well as archives on the website, will be great sources of information for incoming Commissioners.

Commissioner Gove (6A04) reported that there is a string of lights out at Lincoln Park and hopes Councilmember Allen's office will be able to assist. The graffiti on the playground got removed and the retaining wall is still under repair. There are still several vacant properties in the Commission and the Commissioner hopes for better inspections from the Department of Buildings. Sidewalk repairs will be happening along East Capitol Street from December 11 - December 20, 2025 and neighbors should be mindful of 'no parking' signs. The Commissioner recommends having a 'captain block' for outreach and communications.



# Advisory Neighborhood Commission 6A Meeting Minutes of December 12, 2024



Commissioner Shapiro (6A03) is happy to report that, after a year, Adams Market on the corner of 15<sup>th</sup> and F Streets NE finally got a 15-minute no parking loading zone in front of the store. Also, after a year, repairs have started on the outside of Sherwood Recreation Center and the Commissioner hopes they will be done by the end of the year. Crime continues to be a problem, especially in the alley between 11<sup>th</sup> and 12<sup>th</sup> Streets and F and D Streets NE, and MPD has promised to increase patrols in the area. The Commissioner continues to hear neighbor complaints of lack of maintenance of medians, where both DPR and DGS claim this responsibility falls to the other agency. The Commissioner is looking forward to providing testimony to DDOT and continuing to express concerns about sidewalk safety. The Barbara, a building of short-term rentals on Maryland Avenue NE, had a move-out cycle and a large amount of furniture, clothing, and other household items were left outside.

### **Community Comment**

Ms. Jen DeMayo from Councilmember Allen's office thanked everyone that joined the 18<sup>th</sup> annual Brickie Awards. This past Tuesday there was a hearing on the SAFE Act, which would give the Attorney General new tools to force large building owners to make safety improvements when there have been serious incidents. Testimony can be submitted until December 20. 2025. Next Tuesday is the council's final legislative meeting in this 2-year council period. At this meeting, the council will be considering how to address cars using fake license plates, how to better regulate delivery drivers, and proposed changes to how the district works with children and minors who have been convicted of a crime. Ms. DeMayo thanks all the outgoing Commissioners and is appreciative of all their work; she welcomes incoming Commissioners and looks forward to collaborating.
