Advisory Neighborhood Commission 6A Meeting Minutes - June 12, 2025



## Advisory Neighborhood Commission (ANC) 6A Minutes Zoom Meeting June 12, 2025

**Present:** Commissioners Dave Wethington, Jeff Giertz, Stephen Kolb, Paul Spires, and Amber Gove were present. Commissioners Roberta Shapiro and Mike Velasquez were absent.

The meeting convened virtually via Zoom at 7:00 pm.

Commissioner Dave Wethington called the meeting to order and noted the presence of a quorum. The minutes for the ANC May 2025 meeting were accepted subject to any minor or technical corrections approved by the Secretary. The agenda for the June 2025 meeting was accepted by unanimous consent.

The community received meeting notice via listservs, the Hill Rag, ANC website, X, and Facebook.

## **Community Presentation**

Mayor Bowser's FY26 Budget - Mr. Stephen Miller, Chief Technology Officer, Government of the District of Columbia

Mr. Stephen Miller presented the mayor's 2026 Grow DC FY26 budget, noting that, with a population of over 700K last year, the District was growing faster than all 50 states with an improving urban school district, more than 26M visitors, 28 consecutive clean audits and 29 consecutive balanced budgets. Building the FY26 budget was particularly challenging because of the Continuing Resolution passed by the House, dictating that DC was required to reduce its previously approved budget by \$1.13B. The transformational growth agenda leans in on sports, entertainment, and technology and focuses on bringing the Commanders back to RFK, transforming Capitol One Arena, renovating National, Lincoln, and Howard Theatres, reviving the Qualified High Technology Companies tax incentive, investing in tech incubators, supporting start-ups, and expanding gaming opportunities. The budget will also support DC's downtown by hosting activations during the construction of Capital One Arena, launching the Gallery Place Cultural District, increasing new office conversions, implementing citywide retail incentives, and developing a mixed-use community south of the National Mall. DC's FY26 General Funds budget is \$13B and the Capital budget is \$2.6B; the largest share of capital funds continues to be invested in DDOT, DC Public Schools, and WMATA (27%, 20%, and 14%, respectively). The FY26 budget includes \$2.8B invested in public and charter schools, including \$270M for pay raises for staff, \$2B for 30 school modernizations, \$10.7M to replace and modernize technology equipment, and \$3M to continue High Impact Tutoring. The budget also focuses on building a safer DC with a \$30M increase for MPD to hire more officers, \$2M for Safe Commercial Corridor grants, a \$7.3M increase for FEMS, and \$1.3M to raise salaries of 911 and 311 call takers. \$4.6M has been allocated to support the Clean Corridors initiative and \$2.3M to expand curbside composting; \$5.1M is allocated for stormwater management infrastructure. In terms of housing and economic development, HPTF is back at \$100M for FY26, and \$52.4M is allocated to support DC housing improvements. \$166M will be used to complete the modernization of six libraries and





\$188M to support modernization of 22 recreation centers, pools, and parks. \$76M of additional funds are allocated to WMATA and \$6M to transportation of students in Wards 7 and 8. In Ward 6 specifically, \$57M will be used to build more permanent supportive housing and shelter space within Federal City Shelter; \$223M to renovate Amidon-Bowen, Brent, J.O. Wilson, and Shirley Chisolm schools; \$40M to renovate Randall, Rumsey, Sherwood, and RH Terrell recreation centers; \$24M to replace Northwest One Library with a full service neighborhood library; \$402M to maintain streets, sidewalks, and alleys citywide; \$199M for interventions to improve pedestrian and bicycle safety; \$237M to reconstruct the H Street Bridge; and \$19M for a new pedestrian tunnel and entrance to the NoMa-Gallaudet metro station. Commissioners raised concerns that several items such as truancy and violence interruption were not addressed in the budget and found it frustrating that the budget mentioned increases in certain line items but did not cite the baselines.

Some have proposed adding bollards or planters to block along the route which would maintain parking but keep the crossings safe from excessive speed and volume. The motion passed 5-0.

The draft letter will be placed on the July 2025 ANC 6A meeting agenda to allow for community input and a vote by the Commission. The Commission will authorize Commissioner Shapiro to draft the letter and seek community input on the matter. The motion passed 5-0.
- 2. Commissioner Shapiro moved and Commissioner Kolb seconded the motion that ANC 6A approve Scott Kilbourn as a member of the Economic Development and Zoning (EDZ) Committee. The motion passed 5-0.

## Single Member District reports

Commissioner Paul Spires (6A01) reported a decrease in crime in the area, although there was a high-speed chase that ended in a crash at 11<sup>th</sup> and I Streets; community members cleaned up the debris from the incident. There will be a celebration of the opening of Feru and a tasting. The





Commissioner received a call from H Street Main Street as they are applying for a grant to beautify H Street and the Commissioner would like to draft a letter of support for the project.

Commissioner Gove (6A04) reported ongoing pipe replacements across the District and recognized Jen DeMayo for her support throughout the process. There are several neighbors who have suffered power surges and Ms. DeMayo is now helping them get restitution. The Commissioner attended two RFK meetings and noted that the plan is to have the current stadium demolished by fall 2026, though there are no implosion plans and the stadium will continue to be taken down in chunks. The Commissioner is saddened and horrified by the tragic murder of SE resident Marcellus Smith and is looking forward to engaging with neighbors at Open Streets DC

Commissioner Jeff Giertz (6A06) noted that the main resident concern in his SMD is ongoing public safety regarding the 700 block of 15<sup>th</sup> Street; neighbors have continued to complain about drug dealing and use, litter, noise, and other quality of life concerns in the area. To address this, the Commissioner and neighboring ANC Commissioner Marc Friend organized a public safety walk with Councilmember Allen, MPD commanders, and representatives from the mayor's offices and offices. There was a shooting in broad daylight at the bus stop at the north end of 15<sup>th</sup> Street (an area that was included in the safety walk).

Commissioner Kolb (6A07) is grateful to have a relatively quiet neighborhood to represent; the Commissioner attended two block parties over the past month, both of which complained about DDOT issues with sidewalk paving. The Commissioner offered to help but has received no response to 311 requests.

Commissioner Wethington (6A05) is also grateful to represent a relatively quiet neighborhood and in the past month has been working to stay updated on RFK. Many concerns are from those who use the field frequently and are worried about the impact of construction. The city would not commit to keeping the fields open during construction but would do what they can to maximize access to them. There are also concerns about parking and the potential addition of a metro stop. At long last, there is a restoration of a raised crosswalk at the intersection of 14<sup>th</sup> and E Streets and the neighborhood is waiting for bike lanes to be restriped. Finally, any groundbreaking on Kingsman dog park is delayed until at least August.

## **Community Comment**

Ms. Jen DeMayo from Councilmember Allen's office noted that the Council is holding public hearings now and residents can still testify for budget hearings that have not occurred. <u>https://lims.dccouncil.gov/hearings/</u>

Open Streets is happening on June 28, 2025. The Annual Ward 6 Week will be at the end of July and will feature free events across the Ward for different age groups and partnering with several local businesses.

## SWS@Goding Water Intrusion Project Summer/Fall 2025

Small Capital Projects are designed to ensure that every student, teacher, and staff member can learn and work in a safe, comfortable, and energy-efficient environment.

SWS@Goding Water Intrusion Project will waterproof the foundation wall on the south side of the building to eliminate water intrusion. This will require removing the existing playground and excavation along the foundation wall. This work will ensure our commitment to student health and help extend the life of our school buildings.

#### **Duration of Project:**

This project will occur over three months. Construction is slated to start August 5. We are targeting the end of October for completion.

#### What to Expect:

- 1. Noise
  - Typical construction equipment noise throughout the project.
  - The initial demolition of the playground and site is likely to be the most disruptive.
- 2. Safety Measures
  - Fencing and signage will be in place to restrict access to work zones where necessary. Contractors will follow all safety and environmental regulations.
- 3. Community Considerations
  - Parking will be restricted along the north side of F Street from the corner of 9<sup>th</sup> street to the end of the existing playground from 7am to 5pm, M-F. (See the diagram below)
  - No street closures are required however; the sidewalk may be closed periodically.
  - Once school starts, we will schedule construction traffic to ensure student arrival and dismissal is not impeded.

#### Re: H Street NE Bus Priority Project—Support for DDOT's 90% Design Plan for H Street/Benning Road Transit Priority Project

Dear Mayor Bowser, Deputy Mayor Albert, City Administrator Donahue, Director Kershbaum, and Council Member Allen,

On June 11, 2025, at a regularly scheduled, duly noticed monthly meeting of ANC 6C held via teleconference, with a quorum of 6 out of 7 commissioners and the public present, the abovementioned matter came before us.

By a unanimous 6:0 vote, ANC 6C voted to reaffirm its support for comprehensive transit, bicycle, and bus priority improvements along the H Street /Benning Road NE corridor. We continue to believe that this project will significantly enhance safety and mobility for all users pedestrians, transit users, and motorists.

The changes proposed in DDOT's 90% Design Plan will substantially improve the functionality of the X2 (formerly D20), X9, and future transit services, while also calming traffic and improving safety along the corridor.

The dedicated transit lanes will make bus service faster and more reliable, encouraging more people to choose public transportation. The proposed curb extensions and mid-block crossings, combined with a reduction in general travel lanes, will create safer and more accessible crossings at intersections throughout the corridor.

This project also has benefits for local businesses. Studies have consistently shown that access to reliable, frequent transit supports commercial activity along improved corridors. In fact, 25 businesses along this corridor expressed support for similar changes proposed in the 90% Design Plan released last year.

Moreover, any future development of the RFK Stadium site will require robust and efficient transit connectivity from Union Station through the H Street/Benning Road corridor. There is no

feasible way to accommodate demand using single-occupancy vehicles alone. Dedicated transit lanes are essential for moving large numbers of people efficiently, in a space that would otherwise serve far fewer vehicles.

We note that Mayor Bowser recently referred to H Street NE as a potential pre-event destination for stadium attendees. Ensuring those visitors have safe, reliable transit options will be key to avoiding increased congestion in nearby residential neighborhoods. A dedicated transit lane and high-quality bus service are the most effective tools to meet that goal.

ANC 6C is proud to support and work in partnership with ANC 6A, which is submitting a similar letter of support for the 90% Design Plan. This alignment between ANC commissions reflects unified support from communities across the corridor that are committed to safer streets, more reliable transit, and vibrant local business development.

We urge DDOT to move forward with implementing the 90% Design Plan and to ensure that the final design delivers on its promise of safer, more efficient, and more equitable mobility for all corridor users.

Re: Request for Comprehensive Traffic Study at Lincoln Park

Dear Director Kershbaum:

At a regularly scheduled and properly noticed meeting<sup>1</sup> on March 13, 2025 ANC 6A voted 5-0-0 (with 4 Commissioners required for a quorum) and at a regularly scheduled and properly noticed meeting on March 11, ANC 6B voted 9-0-0 (with 5 Commissioners required for a quorum) agreed to co-author this letter to urge DDOT to conduct a comprehensive traffic study Lincoln Park.

Lincoln Park is a premier public space on Capitol Hill, but the traffic patterns around the park do not support a safe environment for pedestrians or cyclists. Traffic issues impacting Lincoln Park visitors include aggressive commuter traffic, speeding facilitated by wide lanes, and poor visibility at crosswalks. Since January 1, 2023, there have been 28 recorded crashes in and around Lincoln Park.

At this moment, there are 16 open TSIs around Lincoln Park, and our ANCs have sent numerous letters petitioning the city to consider specific traffic improvements. But rather than continue to identify issues on an ad hoc basis, we believe strongly that a comprehensive approach is required.

We request that DDOT undertake a traffic study of Lincoln Park under the rubric of Vision Zero. A comprehensive traffic study would identify the safety, walkability and bikeability improvements that would have the beneficial impact we've seen from other improvements to traffic safety in the neighborhood.

Dear Mr. Moosally:

Please be advised that on July 10, 2025, the Advisory Neighborhood Commission 6A, voted X-X-X (with four Commissioners required for a quorum) to send a letter requesting more information about the application for a Medical Cannabis Retailer license for Proper Exotic, LLC (ABRA-12867) at 313 8th Street NE. The vote took place at a regularly scheduled and properly noticed meeting.<sup>1</sup>

The proposed location is within close proximity to several establishments that serve very young children, including a day care facility on 8<sup>th</sup> Street NE. Can you please confirm that the proposed location does not violate the stand-off requirements in DC law and regulation and that the proposed location is or is not congruent with the letter and the spirit of DC laws and regulations designed to ensure medial cannabis establishments are located safely away from children? Dear Director Kershbaum:

At a regularly scheduled and properly noticed meeting <sup>1</sup>on July 10, 2025 our Commission voted X-0-0 (with 4 Commissioners required for a quorum) to urge DDOT to review traffic flow and take action to improve safety on the 1100 block of Atlas Court NE.

This block is frequently used by speeding cars trying to bypass a couple traffic lights on H St NE. It is two full car lanes wide which encourages speeding. There also not stop signs at the ends of each alley. The brick of the alley also continues across the pedestrian path at both alley entrances. These two features lead to cars rolling across the sidewalk at speed. There are also small brick walls on each end of the alley which make it hard for cars to see children on the sidewalk.

Multiple TSIs have been closed out with no further action taken noting that a speed limit of 15 mph suffices. There are multiple dwellings on Atlas Court with front doors that open onto the alley. Those residents have to contend with legally driving cars travelling at 15 mph two feet from their front door.

Please consider making safety improvements to this alley, including but not limited to: stop signs at the ends of the alley before the sidewalk crossings, raised crosswalks across the alley entrances, speed bumps along the alley, and planters or bollards to narrow the alley and curb speeding.

- I. Meeting called to order at 7:04 pm.
- II. Introductions & Announcements. Committee members present: Patrick Bloomstine (Chair/6A01), Jeff Fletcher, and Mark Sussman. Commissioners present: Dave Wethington (6A05/Chair) and Stephen Kolb (6A07)

### III. Old Business

- a. Lincoln Park Task Force
  - i. Chair Bloomstine informed the committee that the joint letter with ANC 6B asking for a comprehensive traffic study of the streets around Lincoln Park was sent to DDOT.
  - ii. Committee member Sussman brought up the revamp of the DC Strategic Bike Plan which will begin later this year and how it will relate to the committee's work on Lincoln Park. He also mentioned that we should talk to community members at Capitol Hill Open Streets to hear what. They think about Lincoln Park.
- b. Capitol Hill Open Streets on June 28. ANC 6A has a tent reserved along the route for this event. The TPS Committee does not have formal plans for this event at this time.
  - i. Chair Bloomstine reminded the committee to sign up for a shift at the ANC 6A tent.

### IV. New Business

- a. 1100 Block of Atlas Court NE. There are no speed bumps or stop signs on a very wide alley.
  - i. Chair Bloomstine noted that the alley is two car lanes wide. It results in a lot of speeding down the alley to get around H St NE traffic lights. There are no stop signs at the ends of the alley. Combined with the alley cobbles continuing across the pedestrian crossing at sidewalks encourages cars to roll across sidewalks at speed. There are also small brick walls at the ends of the alleys which reduce visibility for cars. There is a high likelihood that a pedestrian will be hit by a car while on the sidewalk. CM Allen's recent newsletter highlighted speed bumps that had recently been installed in similar alleys in SW DC.
  - ii. Chair Bloomstine made a motion to send a letter to DDOT requesting they prioritize TSIs filed on this alley and consider speed bumps, stop signs, and lane narrowing in the alley. He also asked that CM Allen's office be cc'd on the letter.
  - b. DDOT Strategic Bike Plan. The district is rolling out the update of its strategic bike plan over next few months
    - i. Committee member Sussman emphasized the importance of the process. DDOT hired an outside firm to help with the revamp. They will collect feedback and expect to complete rewrite in Fall 2026. This is a big opportunity to ask for a lot of help making our streets safer.
    - ii. Chair Bloomstine noted that the DDOT Strategic Bike Plan team will be joining a future TPS meeting.

### V. Community Input

- a. Commissioner Kolb brought up continued issues with speeding and traffic flow on 10th Street NE.
  - i. Committee member Sussman noted that this street is a good candidate for the strategic bike plan.





- ii. Committee member Fletcher asked if it is possible to divert truck traffic off some of these neighborhood streets.
- iii. Chair Bloomstine plans to ask DDOT about truck traffic diversion.
- b. Commissioner Kolb asked if it is possible to remove old WMATA bus stop signs that are out of service. Neighbors are being ticketed for parking in them. Chair Bloomstine plans to ask DDOT about this.

## Re: ANC 6A Response to the Proposed FY26 District of Columbia Budget

Dear Chairman Mendelson and Honorable Members of the Council:

At a regularly scheduled and properly noticed meeting<sup>3</sup> on July 10, 2025, Advisory Neighborhood Commission 6A voted X-X-X (with 4 Commissioners required for a quorum) to approve sending this letter setting forth our primary concerns with the proposed FY26 Budget for the District of Columbia.

Before outlining our specific issues, we want to acknowledge the difficult choices facing the Council and the District in the current fiscal and political climate. We also recognize and appreciate the intensive work by Council committees and staff to improve upon the Mayor's proposed budget in recent weeks.

We firmly believe that any budget approved by the Council should:

- Not be balanced on the backs of the District's most vulnerable residents.
- Prioritize the well-being of medically at-risk individuals, young people, and future generations by addressing the real and growing impacts of climate change.
- Recognize that public safety extends beyond policing and encompasses a range of community-based strategies.
- Avoid unsustainable and inequitable economic incentives, including excessive subsidies for wealthy sports franchise owners and developers.

The following sections expand on these concerns.

## The Proposed Budget Disproportionately Harms Vulnerable Residents

We urge the Council to restore funding for critical programs that directly support low-income and at-risk residents, including pay equity initiatives, paid family leave, childcare workers, Temporary Assistance for Needy Families, housing support, Medicaid, and the DC Health

Alliance. These programs are essential to safeguarding health and economic security - especially as the District anticipates job and benefit losses linked to reductions in the federal workforce.

## **Environmental Stewardship Is a Fiscal and Moral Imperative**

Cutting or redirecting funds away from the Department of Energy and Environment (DOEE) and related initiatives is short-sighted and risks long-term environmental and economic harm. Programs such as Net Zero goals, Anacostia River restoration, stormwater management, the DC Green Bank, and sustainable utility development are not only critical to public health and climate resilience but also contribute to job creation and infrastructure modernization.

## Public Safety Requires a Comprehensive Approach

Effective public safety goes beyond law enforcement. It includes Safe Passage programs to ensure children can travel to and from school securely; robust support for returning citizens and violence interruption initiatives; enforcement capacity for agencies like ABCA to address illegal drug activity; full implementation and funding of the STEER Act to address reckless driving; and infrastructure improvements by DDOT that prioritize pedestrian, cyclist, and transit user safety. These include protected bike lanes, dedicated bus lanes, and the flexibility to update outdated sidewalk standards to support safer and more cost-effective designs.

## **Economic Growth Should Benefit Everyone**

While views vary on redevelopment of the RFK Stadium site, there is consensus that the proposal outlined in the Mayor's budget represents an inequitable and fiscally unsound transfer of public assets. If redevelopment proceeds, the project must be dramatically revised to adapt the scale of parking infrastructure and include a new Metro station. Efforts should be made to expand affordable housing, preserve continuous public access to athletic fields and riverwalk trails, ensure fair compensation to the District through land value, taxes, or fee-sharing agreements, and incorporate strong environmental and labor standards.

## **ANC 6A-Specific Concerns**

In addition to the citywide issues above, we highlight several priorities that directly impact ANC 6A and Ward 6:

- Funding to advance previously committed capital projects, including the full renovation of Rumsey Aquatic Center (with the addition of a second floor) and the Kingsman Dog Park and field renovations;
- Continued modernization of Ward 6 public schools and recreation facilities;
- Expanded programming and operating hours at Sherwood Recreation Center.

We also encourage a renewed focus on accountability and long-term value in the Capital Budget. For example, systemic construction flaws at School-Within-School (SWS) are now being corrected with District funds rather than by the responsible contractor, who continues to receive





new District contracts. Similarly, preventable HVAC failures point to the urgent need for improved maintenance planning and execution by DGS.

In closing, we recognize the enormity and complexity of the Council's task during this budget cycle. We thank you for your commitment to the residents of the District and your consideration of the concerns we have raised.

At a regularly scheduled and properly noticed meeting<sup>4</sup> on July 10, 2025 our Commission voted X-0-0 (with 4 Commissioners required for a quorum) to support DDOT's Notice of Intent NOI-25-168-CPD.

This Commission believes that this extension of the project previously presented to this committee in NOI-24-352-CPD will improve safety and mobility for all users of the road, including pedestrians, cyclists, and motorists. The proposed changes will close a critical gap in the protected bike lane network by connecting the newly installed Florida Avenue NE bike lanes with the southbound 14th St NE bike lanes that connect to several other bike lanes in the Eastern portion of Capitol Hill.

This is a critical stretch of protected bike lanes. Crossing H Street NE and Maryland Ave NE on a bike is often a dangerous proposition, so creating the first protected crossing for cyclists is an achievement to be celebrated. The plan proposed in the original NOI was a great step forward, and extending the protected bike lanes to G Street NE instead of ending them at Maryland Avenue NE makes the plan even better. Many neighbors have witnessed dangerous and erratic driving behavior at 14th, Maryland and G Streets due to traffic around the Chick-Fil-A and the 2-way stop at 14th and G Streets. Extending the protected bike lanes will make this road segment even safer for all road users.

The Commission was not entirely sure about the buffer between bike and car lanes on this new segment based on the illustration in the NOI. As such, the Commission recommends that sturdy barriers be used in addition to flex delineators to prevent cars waiting for Chik-Fil-A from parking in the bike lane.

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written Notice of Intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications along 14<sup>th</sup> Street NE between Maryland Avenue and G Street NE in your jurisdiction:

- Install a 6' protected bike lane along the west side of 14<sup>th</sup> Street NE between Maryland Avenue and G Street NE
- Relocate the existing Zipcar parking on the west side of 14<sup>th</sup> Street to the 1400 block of G Street NE on the north side
- Bring the general-purpose travel lane width up to DDOT standards of 11'
- Stripe a 7' buffer between the curb and the general-purpose travel lane on the east side to deter illegal parking

DDOT is proposing to close a bicycle network gap along 14<sup>th</sup> Street NE between Maryland Avenue NE and G Street NE. This proposal is in response to community feedback received during the January 2025 presentation of the 14<sup>th</sup> Street NE Spot Improvement Project, from Florida Avenue to Maryland Avenue NE, to ANC 6A's Transportation and Public Space Committee, as well as comments submitted in response to NOI #24-352-CPD. This proposed project serves as an extension of that effort, expanding the project limits from Maryland Avenue NE to G Street NE to install a protected bicycle facility.

This project will connect to the proposed protected bike lane on 14<sup>th</sup> Street between Florida Avenue to Maryland Avenue and to the existing bike lane on 14<sup>th</sup> Street beginning south of G







Street NE. Filling in this approximately 35 foot gap in the bike lane network will help provide a safer and more comfortable experience for bicyclists and micromobility users as they will no longer have to merge with vehicular traffic approaching G Street NE. The location of the proposed bike lane connection is shown below in red.

This project will involve the relocation of the existing Zipcar parking along the west side of 14<sup>th</sup> St NE to the 1400 block of G Steet on the north side to accommodate a 6'protected bike lane along the west side of 14<sup>th</sup> St NE. The images below show the existing roadway layout (Figure 2) and the proposed roadway layout (Figure 3) to accommodate the protected bike facility along 14<sup>th</sup> St NE.

### Re: ANC 6A Support for BZA #21323 of Steven & Natalia Graham

Dear Ms. Mehlert,

At a regularly scheduled and properly noticed meeting<sup>5</sup> on July 10, 2025, Advisory Neighborhood Commission 6A voted X-0-0 (with 4 Commissioners required for a quorum) to support the request for Steven & Natalia Graham at 424 7th Street NE, BZA case number 21323. The applicants proposing to add a two story plus basement rear addition to an existing single-family dwelling. The property is to remain a single-family dwelling. Specifically, the applicants requested a Special Exception for relief from the read yard requirements of Subtitle E § 207.1, pursuant to Subtitle E § 5201 and Subtitle X § 901.2.

This project was included on the agenda for the May 21, 2025 meeting of the ANC 6A Economic Development and Zoning Committee. At that time, we received no comment from members of the public or from within the Committee. Accordingly, the Committee has taken no formal action on the matter. With regard to any specific concerns, potential protest, or support for the proposed development, we defer to our colleagues in ANC 6C to evaluate and represent the interests of affected stakeholders, as the property in question is located within their Single Member District.
