Advisory Neighborhood Commission (ANC) 6A Minutes Virtual Meeting via Zoom October 12, 2023

Present: Commissioners Amber Gove (Chair), Keya Chatterjee, Roberta Shapiro, Dave Wethington, Robb Dooling, Steve Moilanen, and Mike Velasquez were present.

The meeting convened virtually via Zoom at 7:00 pm.

Commissioner Amber Gove called the meeting to order and noted the presence of a quorum. The minutes for the ANC 6A September 2023 regular and special meetings were accepted. The agenda for the October 2023 meeting was accepted by unanimous consent.

Community Presentations

Commander Colin Hall, Captain Sherrelle Williams, Lieutenant Araz Alali, Metropolitan Police Department (MPD) First District (1D)

Commander Colin Hall and his colleagues noted that MPD is focused on improving the neighborhood and making the community as safe as possible, though several issues such as mental health and homelessness are beyond MPD's control. On a recent 1D multi-agency H Street walk, MPD noted several issues in the area and got feedback from residents in the area about people using the alleys as restrooms, graffiti, trash, etc. MPD is deploying resources across the city to monitor several protests and events related to the Israeli/Palestinian conflict, while simultaneously responding to neighborhood safety requests. Recently six (6) arrests were made in the area and have set up a bike unit along H Street who are making arrests and enforcing quality of life issues as well as engaging with the community and local business owners. Though progress has been made since the beginning of the year, there are still many robberies happening and extra layers of robbery patrol and suppression have been added throughout the areas seeing persistent robberies, such as the north and south sides of Lincoln Park. Gun violence is also prevalent across the city and the violent crimes division has been very effective in getting guns off the street and apprehending gun violence perpetrators. MPD has been keeping pressure on the Attorney's Office on key arrests to paper these cases and is also training officers on anticipating how the US Attorney's Office will think and act and operate in a manner that will help the case get papered. There is a gun reward program for tips from residents - anyone can text 50411 or 727 9099; these text tips help MPD track trends. The camera rebate program is also highly recommended and can help with a variety of crimes including package theft and carjackings, which are still prevalent due to a popular TikTok challenge. Dangerous driving remains an issue, and several officers have been dedicated to traffic safety, especially around schools. In terms of retention at MPD, the organization has fifty-eight (58) officers more than was previously projected; salaries have been improved, hiring bonuses are \$25,000, and housing assistance is provided. Anwar Saleem, Executive Director, H Street Main Street

Mr. Anwar Saleem urges more presence from the DBH on H Street, as the MPD cannot address mental health and homelessness issues. HIPS on H Street is helping the corridor but more needs to be done for a stronger impact. Several agency programs do not result in any actual or meaningful change in the

community. The Main Street area covers not only H Street but is about 3.5 miles and stretches between Bladensburg Road, Mt. Olivet Road, and Kenilworth Avenue NE. A survey conducted recently with businesses along H Street found that safety along the corridor was a main concern, so Mr. Saleem has been working with MPD, the Department of Housing (DOH), DBH and other agencies, as well as with nightlife establishments along the corridor who need to take responsibility and ownership of their customer bases. Security wands will be purchased for these businesses as well as ID scanners for records of all people that come through the building. Mr. Saleem has been placing young people from the area into businesses of interest during the summer, but there need to be more outlets throughout the school year and summer for their energy and time, as well as better infrastructure to prevent crime. Monthly safety meetings will continue, and H Street Main Street will continue to promote establishments along the corridor to highlight their offerings and build larger customer bases for the area. Part of this initiative is a video highlighting some of the corridor's best businesses in conjunction with posting ads across social media and newspapers. There are five major events throughout 2024: Small Business Saturday, Summer Music Series, Day of Dignity, Art All Night, and the H Street Festival. The process has started in developing a Business Improvement District (BID) on H Street. H Street does manage a clean team of three members, but they need a larger budget.

Officer Reports:

1. The October 2023 Treasurer's report by Commissioner Steve Moilanen reviewed the three expenditures accrued in September: \$765.89 for webmaster services, \$250 for notetaking, \$58.29 for Zoom Premium, (checks #2071-#2073, respectively). The opening uncommitted funds available were \$30,911.33. After accounts payable totaling \$1,074.18 the closing available checking balance is \$29,962.20. The savings account opened at \$100.05, gained no interest, and closed at \$100.05, and petty cash remained at \$25. The Treasurer's report was approved by unanimous consent.
2. Commissioner Gove moved and Commissioner Roberta Shapiro seconded the motion that ANC 6A submit the FY2024 budget plan as outlined here by Commissioner Moilanen: expected expenses of \$12,890 for regular notetaking and webmaster services and Zoom Premium, plus \$100 of miscellaneous quarterly expenses, and an estimated \$1,000 per quarter in grants yielding \$17,290 annual expected expenses. On the revenue side, OANC said to expect \$4,625 per quarter, yielding \$18,500 annually. The motion passed 7-0.
3. Commissioner Moilanen moved and Commissioner Gove seconded the motion that ANC 6A renew service agreements for package prep/web services and notetaker for FY2024. The motion passed 7-0.

The big changes include an increased island for pedestrians and strollers and bringing existing pedestrian ramps to ADA standards; DDOT is hoping to break ground on this project in November and the ANC recommended that they engage with Wine and Butter and consider delivery trucks/loading, as well as raise the crosswalks. New Business

Commissioner Robb Dooling moved and Commissioner Keya Chatterjee seconded the motion that ANC 6A send a letter of support to DC Councilmembers for the Open Movie Captioning Requirement Act of 2023. This act would require certain DC movie theaters to provide closed captioning at specific showings, a move toward more accessibility in the District. The motion passed 6-0. (Commissioner Shapiro had left the meeting.)

Commission Business

Single Member District (SMD) reports

Commissioner Dave Wethington (6A05) had Commander Hall and the First District team, as well as Ms. Jen DeMayo from Councilmember Charles Allen's office and Mr. Jake Stolzenberg, Ward 6 MOCRS, at his SMD and had a great discussion with residents about neighborhood incidents including robberies. The Commissioner reminded the community to be careful while crossing streets due to traffic safety issues in the District and has also been handling abandoned property concerns. The Commissioner is grateful to the Commission for sharing parking information to pass along to constituents.

Commissioner Mike Velasquez (6A02) noted increased narcotics enforcement at 8th and H Streets and is glad to see increased constituent safety and patronizing of H Street. The Commissioner testified in person at the transportation committee and made sure the Council understood that ANC 6A had passed letters of support. Together with Commissioner Dooling, he met with the representatives of where KitchenCray used to be to discuss what else could be at that location. There are concerns over deliveries at the Nike store as well as human waste in the alley; the Commissioner is looking for support in getting the city to handle it and be responsive - there is not ability to report an incident of human feces to 311, so the recommendation is to report it as animal feces, though this has not been historically effective.

Commissioner Moilanen (6A07) commends the city on the launch of the curbside compost program (the Commissioner's family is among the pilot program). This is part of the city's ambition and commitment to diverting 80% of solid waste by 2032. The Commissioner also offered a note of gratitude for all the work that went into maintaining the Fields at RFK. For Halloween there is no better place to be than East Capitol Street and the Capitol Hill neighborhood in general and he is looking forward to seeing neighbors in costumes.

Commissioner Dooling (6A06) had a productive meeting with representatives of the property where KitchenCray was located with Commissioner Velasquez and shared ways that ANC 6A can help tenants

thrive. The Commissioner briefly met with the owner of the new H Street Country Club space, which is planning to open spring 2024 - the owner lives in the neighborhood. On Monday, October 16th there is a DC Streetcar event with three councilmembers at 3939 Benning Road NE in Ward 7: <https://tinyurl.com/dcstreetcar2023>. The Commissioner also met with the owner of H Street Liquors to provide resources on safety and how they can grow. All Traffic Safety Investigation (TSI) locations near Miner Elementary School were selected for deeper safety observation.

Commissioner Chatterjee (6A01) reported that there are finally visibility crosswalks painted in front of JO Wilson. There are many items coming up on the October 17, 2023 TPS agenda, including Florida Avenue issues, where DDOT is finishing the portion of 2nd - 7th Streets. Five commissioners participated in the walkthrough last month during which multiple safety issues were raised. She urges community members to be careful on Halloween as it is the night of the year with the most pedestrian fatalities, so have fun and be careful.

Commissioner Gove (6A04) highlighted appreciation for the recent MPD walk and Spiderman movie screening; there will be another movie on October 27, 2023, Coco. She attended the RFK virtual meeting; the stadium is still supposed to come down by the end of the calendar year, but the community would love to see more transparency from the Events DC team. The mayor will be at the October 18th meeting at 320 21st Street NE at 7:00 pm and community members can learn more and take a survey about RFK preferences at www.rfkfuture.org. Walk and Roll to school day was a great event, although there was also a hit and run on 12th and C Streets NE. Hill Family Biking is organizing a large group ride featuring a Hill is Home judge and there is a costume contest with prizes.

Community Comment

Jen DeMayo expressed appreciation to those that took the time to testify at the traffic and safety hearing. On Wednesday, October 18, 2023 there will be a hearing on the appointment of Mr. Hanlon as Director of the Department of Buildings,. There is a new program to extend certain incentives and benefits to 911 call takers. More information on RFK: <https://www.hailnorfk.com/>

MOCRS Jake Stolzenberg gave an update on MPD walks on Ward 6 and there might be more on H Street; it is helpful to hear concerns on specific items and alleys. There is a walk on Tuesday at 3:00 pm along H Street. Mayor Bowser has made several statements on cracking down on carjackings on Capitol Hill, which have decreased since summer has wound down. DC has several jobs available and many hiring events coming up.

The meeting adjourned at 9:35 pm.

PROJECTpipes 1:

- 2014-2019
- Cost \$110 million

WGL is Greenwashing PROJECTpipes

WGL claims that:

- “PROJECTpipes work has...reduced greenhouse gases released from its distribution system.”
- “The program will enhance the safety and reliability of DC’s pipeline system”

The truth is that:

- PROJECTpipes 3 will further lock DC into a gas pipeline system, resulting in more greenhouse gas emissions in the future
- Methane gas is dangerous for consumers and hazardous gas leaks in DC’s system have increased by 15% in the last 6 years



What’s wrong with PROJECTpipes?





1. Blocks DC's Climate Goals

- DC has a climate pledge of net carbon neutrality by 2045
- WGL is investing huge amounts of ratepayer money to **replace** miles of pipeline in DC, forcing re-investment in gas infrastructure
- A better solution is to **repair** the worst pipes, knowing that DC will electrify in the coming years.

Putting billions into gas infrastructure directly contradicts DC's carbon neutrality goals.

2. Energy Equity

- WGL is forcing ratepayers to bear the burden of Project Pipes
- As DC electrifies, wealthier households will be the first to move off of the gas network
- This means that the remaining ratepayers will be lower-income residents, who will be forced to bear disproportionate costs of Project Pipes

Ratepayer burden affects low-income households the most.

3. Public Health

- Burning methane releases toxic substances like nitrogen dioxide that cause harmful indoor air quality.
- Burning methane is **dangerous** for households because it is linked to respiratory, cardiovascular, and other illnesses.
- Gas stoves can leak methane even when they are turned off.

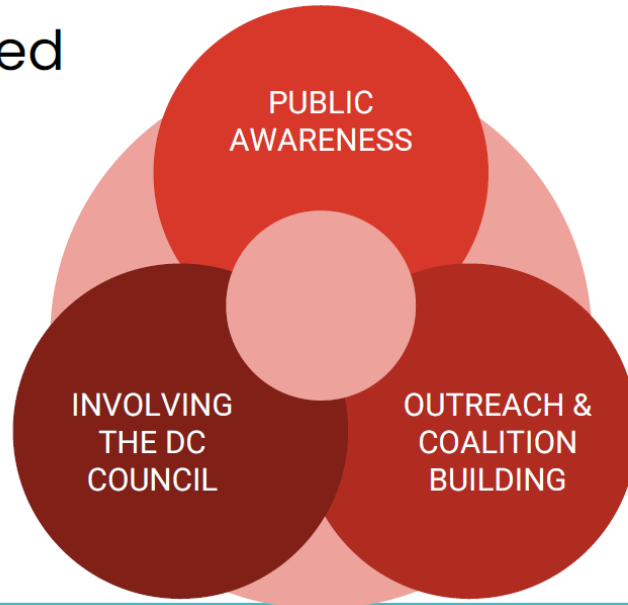

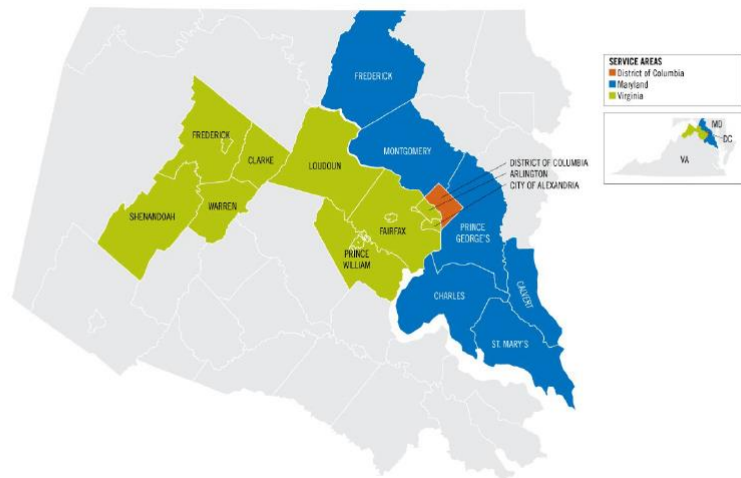

Re: ANC6A Support for NOI-23-198-TESD

Dear Mr. Diallo,

At a regularly scheduled and properly noticed meeting¹ on October 12, 2023, our Commission voted 6-0-0 (with 4 Commissioners required for a quorum) to express our support for the above-referenced [Notice of Intent](#). As noted in DDOT’s letter dated September 8th, 2023:

“Vision Zero Hardening is a DDOT program that upgrades existing tactical safety improvements to Permanent. Tactical safety improvements are temporary and often consist of semi-permanent materials such as flex posts, striping, and rubber wheel stops. DDOT installs these to address safety concerns quickly, and the Vision Zero Hardening program identifies high-priority locations to upgrade annually.

The proposed design will extend the existing curb and provide a large pedestrian refuge island at 11th Street NE and East Capitol St NE. The curb extensions will improve visibility for drivers so pedestrians waiting to cross will be seen easily. Also, the proposed design will shorten the crossing distance, improving safety for pedestrians and reducing vehicle turning speeds. The extension of the refuge island will increase dwell space for given the large pedestrian volume. The traffic signal will also be updated to improve pedestrian safety.”

We appreciate DDOT’s efforts to convert flex posted/painted areas to more permanent infrastructure under this Vision Zero Hardening program-- both for the improved safety aspects as well as the improvement to aesthetics through the removal of what are meant to be temporary flex posts. We note in particular our support for the proposed curb extension on the south side of East Capitol Street, which eliminates a no-parking curb lane (essentially an extension of the bus stop) that can currently be used to make an illegal right turn, endangering drivers in the travel lane as well as customers at the nearby outdoor café.

Our Commission has the following observations and recommendations.

1. **Raise the Crosswalks and Expand the Pedestrian Refuge.** Please consider making the crosswalks across East Capitol Street raised. Raising the crossing here would help to reduce driver speeds. Drivers turning right from 11th Street to East Capitol frequently take the turn at

high speeds. There is high pedestrian density at this intersection. The “up and down” nature of 4 curb cuts in a row would slow down people using strollers, scooters, bicycles or wheelchairs. A raised crosswalk gives those crossers an easier trip. While we understand the curb extensions would help to slow vehicles, a raised crossing would also slow vehicles and be safer for all road users. This would also help to increase the size of the pedestrian refuge space which is frequently crowded/overflowing with people. The version presented at the 6B Transportation Meeting included narrow passageways at street level-- for the reasons stated above we feel this design is insufficient and strongly recommend a complete at-grade crossing.

- 2. Clarify/Improve navigation for people using micromobility/bicycles.** The additional curb extensions on the north side of the roadway will narrow the vehicle travel lane and may hamper the ability of micromobility/bicycle users turning right onto East Capitol from 11th Street NE to access the painted/unprotected bike lane. Can DDOT please clarify the recommended travel path for micromobility/cyclists traveling in this direction? Should they take the middle of the turn lane? Is there space to create a protected intersection/path for micromobility users similar to that at New Jersey and I Streets Southeast? Please consider adding a bicycle box and/or signage in front of the stop bar and behind the crosswalk at East Capitol on the south side of the intersection to allow micromobility users to turn right safely ahead of vehicles—similar to the one between the stop bar and the crosswalk on East Capitol NE at 11th Street NE, northeast corner of the intersection).
- 3. Remove the slip lane and reduce the turning radius from 11th St. to East Capitol westbound.** DDOT should consider reducing the turn radius from 11th Street. to East Capitol to be similar to its parallel counterpart on the south side of the intersection. Not only would this reduce the speed of vehicles traveling through the intersection when combined with the already-proposed hardening projects, but it would also force drivers to think of the 11th Street/East Capitol Street intersection as an actual intersection with different modes of transportation instead of a merge area to blow through. If the turn radius for the southern side of the intersection is good enough for DDOT, then there should be no problem in reducing the radius of the westbound turn.
- 4. Consider bioswales and other green infrastructure.** Did DDOT consider green infrastructure such as bioswales for this location? If bioswales are not possible, would the addition of planters, maintained by the community, be an option that DDOT would consider adding?
- 5. Conduct a comprehensive review of pedestrian and vulnerable road user safety around the entirety of Lincoln Park.** According to DDOT’s Traffic Safety Input dashboard, there are at least 19 TSIs that have been submitted under the new TSI process for the blocks abutting Lincoln Park: 6 are pending installation, 6 are classified as completed, and another 7 are for future consideration. As DDOT is well aware, the multiple-threat crosswalk configuration is one of the most dangerous designs for pedestrians—there are 6 such crosswalks at this location. We respectfully request that DDOT study the Lincoln Park corridor in its entirety, rather than through piecemeal TSI responses examining one intersection at a time. Our Commission welcomes a thorough review of all of the options that will improve safety for pedestrians and other vulnerable users. This is a heavily used pedestrian gathering space with two schools within one block—we urgently need to make access to the park safer for all.

Dear Chair Mendelson, Councilmembers Bonds, McDuffie, Gray and White:

At a regularly scheduled and properly noticed meeting¹ on October 12, 2023, our Commission voted 6-0-0 (with 4 Commissioners required for a quorum) to support the Open Movie Captioning Requirement Act of 2023. In February 2023, an Open Movie Captioning Requirement Act for DC was re-introduced by 8 of 13 Councilmembers. This legislation would require open captioning in just 12% of showings at DC movie theaters.

The DC Deaf Moviegoers Group led by Erik Nordlof, Reema Bogin, and Brianne Burger has advocated for this legislation since 2018 following the success of similar legislation in Hawaii and New York City. Open captioning benefits young children, English learners, senior citizens, military veterans, and other individuals, both with and without hearing loss. The UK Office of Communications found that 80% of captioning users have no hearing loss at all, which underscores that accessibility is universal. The legislation will have no cost for DC movie theaters because open captioning is available but deactivated in current showings.

Deaf, DeafBlind, and Hard of Hearing citizens have made invaluable contributions to the ANC 6A community, including:

- Gallaudet University hosted the ANC 6A website, www.anc6a.org, and provided technical support to ANC 6A for 10 years from 2003 to 2013.
- ASL Trivia DC, co-founded by a Deaf ANC 6A resident in 2014, regularly brought 100-200 customers to small businesses on H Street NE on Monday evenings throughout the 2010s.
- Mozzarella at 1300 H Street NE in ANC 6A is the first Deaf-owned-and-operated restaurant in DC and a source of neighborhood pride.

Dear Mr. Goodno:

At a regularly scheduled and properly noticed meeting¹ on November 9, 2023 our Commission voted 5-0-0 (with 4 Commissioners required for a quorum) to:

1. Support DDOT's request to close the gap in the bicycle lane network, including with an extension of bike facilities on K Street NE from 7th Street NE to 8th Street NE, with reference to [NOI-23-223-PSD](#), and support additional green space and a pocket park at 8th and K Streets and West Virginia Avenue NE;
2. Request that DDOT use the left turn lane on the 700 block of K Street NE to create space for the bicycle lane, thereby slowing traffic on K Street NE;
3. Request Pick-Up and Drop-Off (PUDO) spots on K Street NE and/or 8th Street NE for residents to load their vehicles, etc.;
4. Narrow vehicle lanes to 9 feet: <https://narrowlanes.americanhealth.jhu.edu/>;
5. Explore protection of the bicycle lane, especially after narrowing the vehicle lanes; and
6. Study the turn radius of large vehicles from West Virginia Avenue onto K Street NE, and redirect large vehicles to another route as needed.

Last year an ANC 6A constituent, Ralph Williamson, was killed on K Street NE when a driver crashed into him as he was unloading groceries. Slower speeds and pick up and drop off zones could have prevented that fatality and are therefore in our request today. This extension will improve safety for all road users and provide an important connection between the K Street NE and West Virginia Avenue bicycle facilities. The bicycle lanes would also connect to the pocket park to be installed at the intersection of West Virginia Avenue and K Street NE for increased stormwater retention. The District's multimodal long-range transportation plan includes these blocks as a part of the Bicycle Priority Network. Having a safe, low-stress bicycling network is critical. A safe systems approach includes this element for safer roads: "Design roadway environments to mitigate human mistakes and account for injury tolerances, to encourage safer behaviors, and to facilitate safe travel by the most vulnerable users."

In addition to reducing traffic violence and fatalities, we are concerned about the impacts of climate change on our neighborhood such as increased rats, mosquitoes, mold, and flooding. This moves us to

support safety interventions for residents. This project will create a buffer for residents traveling on the sidewalk and increase their safety, create a safer spot for bicycle riders, as well as slow traffic which will increase safety for all users.

The installation of bike lanes on K Street NE between 6th and 8th Streets.

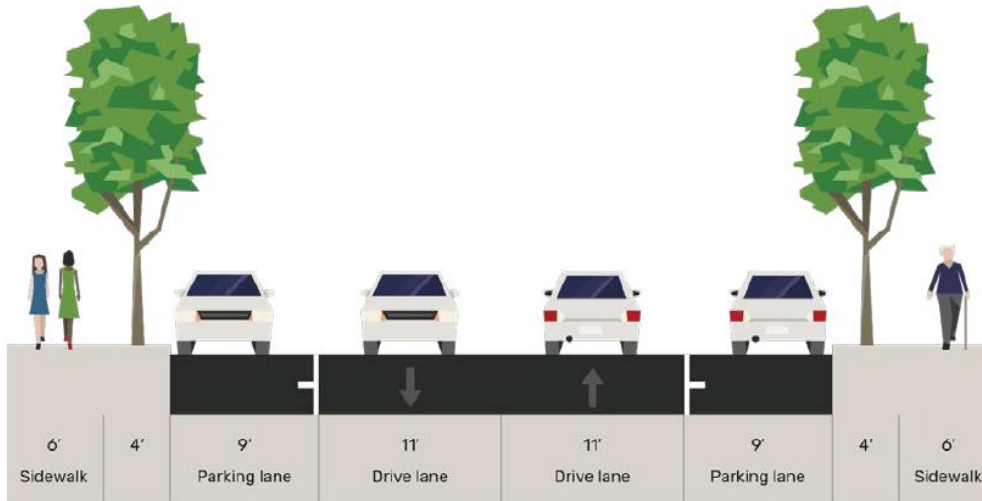
Overview:

DDOT recently resurfaced the 600-block of K Street NE. Now that the street is clear of lane markings it is a good opportunity to extend the bike lanes east to 8th Street. This extension would fill a gap between the K Street bike lanes and protected lanes on West Virginia Avenue. People could then bike and scooter in dedicated lanes from Mount Vernon Square to Gallaudet University, Trinidad and Ivy City. The existing and proposed cross sections are shown below:

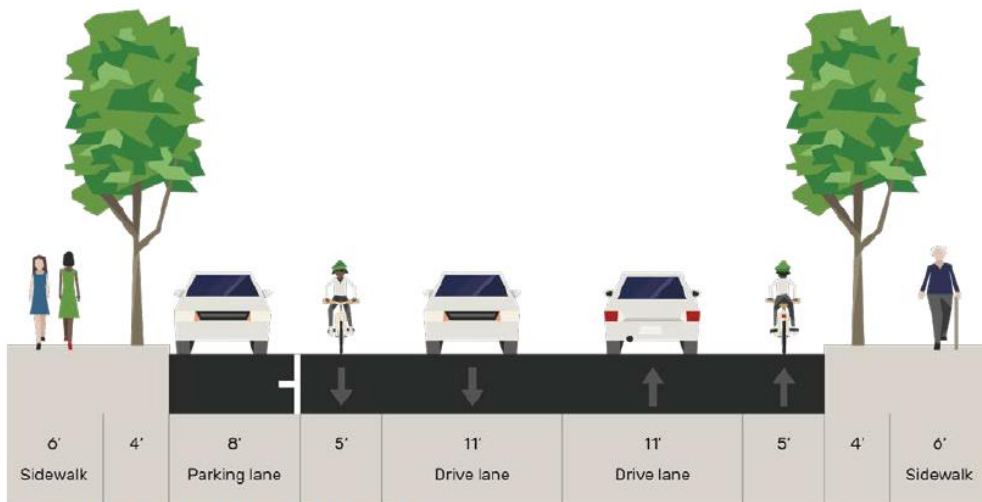

Existing Conditions 600-block of K Street NE



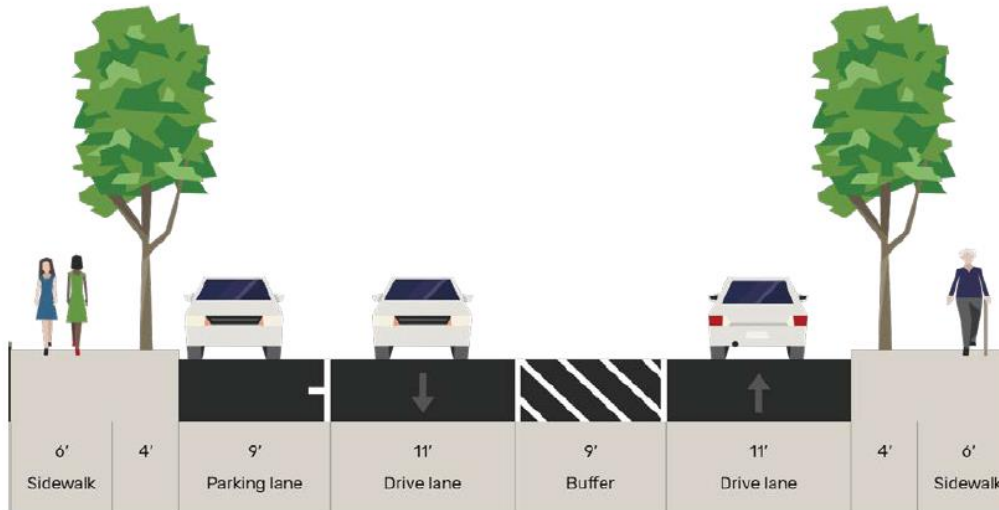
Proposed Conditions-600-block of K Street NE

In the 600-block parking would remain on the north side of the road. On the south side, however, the 460-foot (approximately 23 RPP spaces) would need to be removed to obtain space for the bicycle lanes.

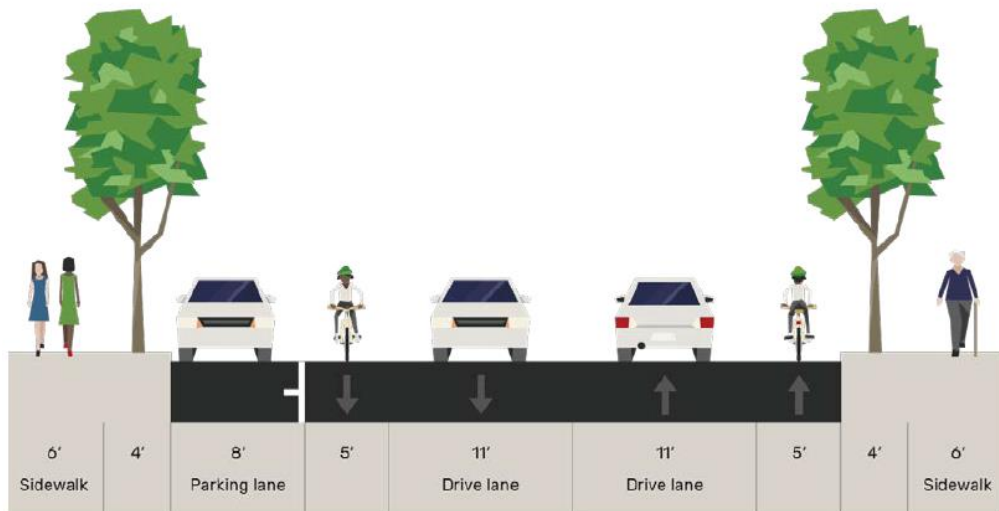
There is no parking in the 700-block. Space for the bicycle lanes would be obtained from the removal of the hatched median. See existing and proposed cross sections below:

Existing Conditions-700-block of K Street NE

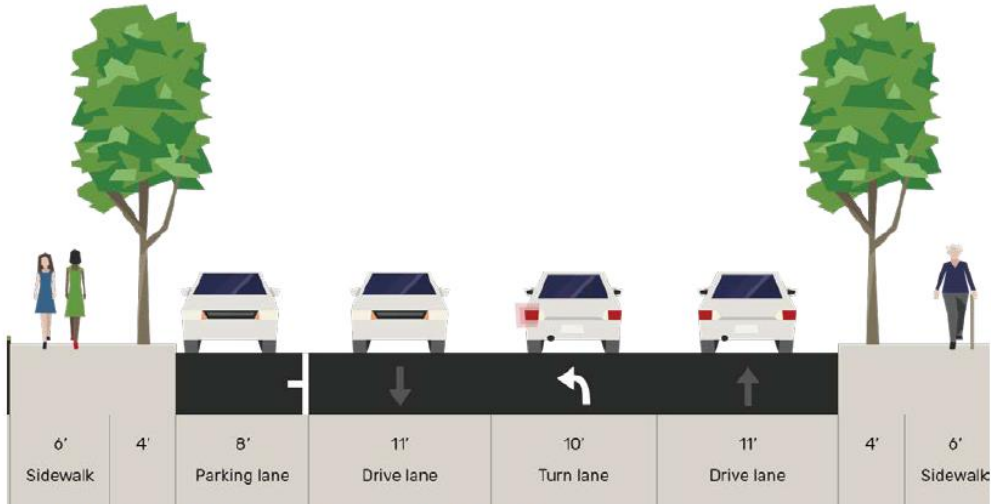


Proposed Conditions-700-block of K Street NE

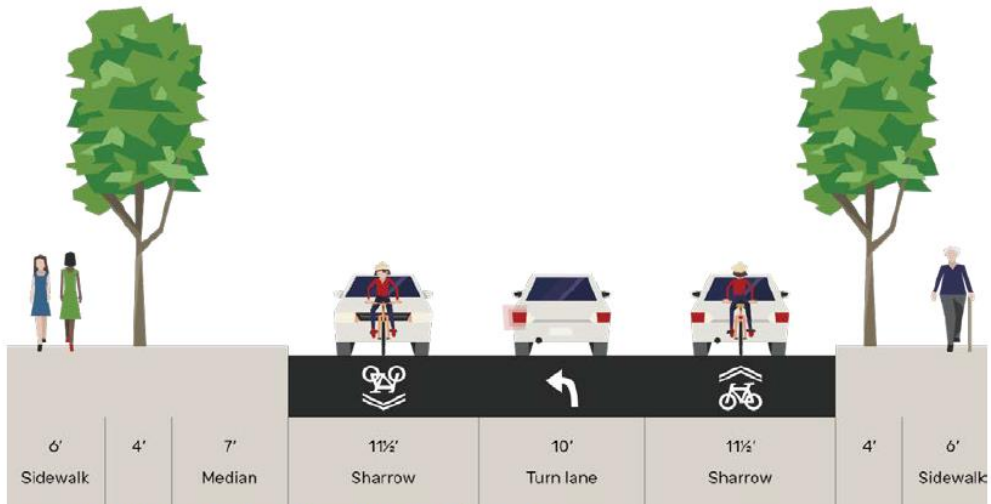
The upcoming *Multipurpose Green Infrastructure Storm Water Retrofits* project will permanently close the southernmost leg of West Virginia Avenue. This development will extend the curb 7-feet south at the intersection of K Street and 8th Street and prevent the continuation of the bicycle lane to 8th Street. Bicyclists and motor vehicles would share the travel lanes in the short segment between West Virginia Avenue and 8th Street. DDOT anticipates the following safety benefits with this project:

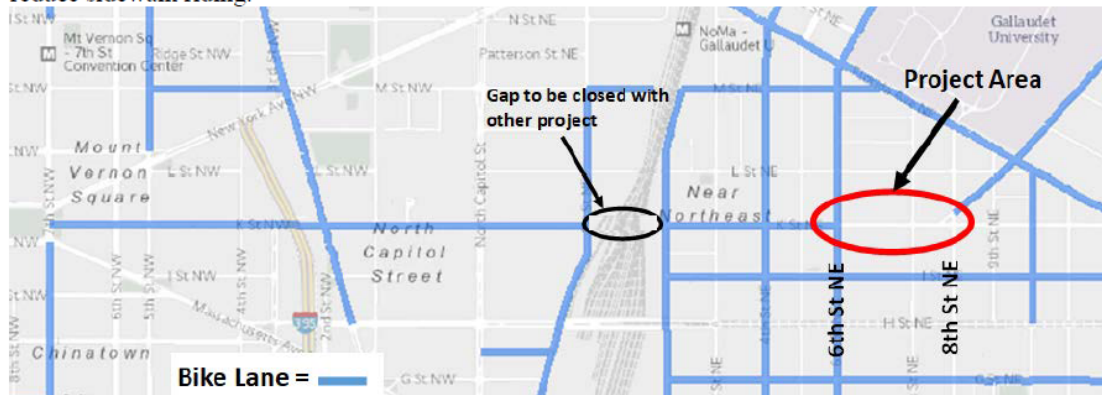
- An expanded biking / scooter route for people traveling along K Street NE.

- Improved comfort and safety for people biking / scootering between K Street and West Virginia Avenue.
- Reduction in motor vehicle trips due to faster and safer non-motorized travel options.

This proposed segment closes a 0.06-mile gap in a nearly continuous 2.7-mile section of connected bicycle lanes between 7th Street NW and New York Avenue NE. Another project is underway to close the gap between 1st and 2nd Streets NE. It is an important part of DDOT’s work to improve safety for all roadway users. Bicycle lanes are also used by scooters and other personal mobility devices and found to reduce sidewalk riding.

Pursuant to notice duly given, a meeting of the Alcohol Beverage Licensing Committee (“Committee”) of ANC 6A was held commencing at 7:00 pm ET on October 24, 2023, on a publicly posted Zoom event.

- I. Call to Order/Approval of Agenda/Approval of Minutes
 - Chair Sullivan called the meeting to order at 7:01 pm.
 - The minutes from the September 26, 2023 meeting of the Committee were approved without objection.
 - The agenda was approved without objection.
- II. Community Comment
 - Chair Sullivan asked if any members of the community in attendance wanted to make any comments not related to one of the establishments on the agenda. There were no comments.
- III. New Business
 - Discussion of application of DSAY Corporation t/a Adams Market at 700 F St. NE (ABRA-077168) for renewal of its Class B Retail-Grocery License.
 - Chair Sullivan stated that Adams Market is seeking a renewal of its grocery license. She noted that there is no settlement agreement process with grocery stores.

 - Committee member Blumenthal seconded the motion and the motion passed unanimously.
 - Discussion of application of Jerk at Nite, Inc. t/a Jerk at Night at 1100 H St. NE (ABRA-126009) for a Class C Restaurant License.
 - Chair Sullivan stated that Jerk at Night has been operating, first as a food truck and now as a brick and mortar, and that they are now seeking to serve alcoholic beverages.

 - Chair Sullivan shared that Commissioner Chatterjee suggested that the Committee consider taking advantage of the resources the city provides to have the standard settlement agreement reviewed to make recommendations on what provisions are duplicative of DC law versus in addition to DC law in order to simply and clarify the agreement to make it easier for small businesses to review and understand.
 - The Committee also discussed potentially preparing a plain English letter to business owners to accompany the settlement agreement.
 - Commissioner Velasquez indicated that the Office of the General Counsel of the ANC could be a resource, and perhaps the ANC can write a letter to ABCA.
 - Discussion of cannabis establishments
 - Commissioner Velasquez raised whether cannabis establishments were within the scope of this Committee's authority, and indicated that he would discuss with the ANC.

The meeting was adjourned at 7:32 pm.

- d. Applicant, and all employees that are designated to serve alcoholic beverages, shall attend and complete an alcoholic beverage server training course/seminar.
- e. Applicant shall make every commercially reasonable effort to prohibit and prevent criminal activity on or in front of the establishment premises, to include:
 - i. Calling appropriate emergency services if illegal activity is observed;
 - ii. Keeping a written record of dates and times (a “call log”) when the establishment calls emergency services for assistance ; and
 - iii. Applicant will maintain a detailed incident log. An incident is defined as any activity by patrons of the establishment that lead to acts of violence or damage to property. Each incident will contain the date, time, and location of each incident with a concise summary. Guests and staff involved or witnesses of the incident will be identified and listed. If there is a medical or police response, that information will also be noted.
- f. Upon request of the Board, Applicant’s call log and incident log shall be provided to the Board.


- e. All CT license holders with an entertainment endorsement must have an ABRA-accepted security plan in place.



 - ii. Keeping a written record of dates and times (a “call log”) when emergency services are called for assistance; and
 - iii. Applicant will maintain a detailed incident log. An incident is defined as any activity by patrons of the establishment inside or immediately outside the establishment that could lead to an ABRA investigation. Each incident will contain the date, time, and location of each incident with a concise summary. Applicant and employees will make reasonable efforts to identify and list any guests and staff involved or witnesses of the incident. If there is a medical or police response, that information will also be noted.

- j. Upon request of the Board, Applicant's call log and incident log shall be provided to the Board.

- l. Applicant shall provide valet parking services only with valet parking companies as defined, licensed, and in compliance with D.C. Municipal Regulations Title 24 Chapter 16.

ANC 6A Transportation & Public Space Committee Meeting Tuesday, October 17, 2023 at 7:00 pm Virtual Meeting via Zoom

- I. Meeting called to order at 7:01 pm.
- II. Introductions & Announcements.

Committee members present: Shaun Lynch (Co-Chair), Jeff Fletcher, Mark Sussman, Paul Angelone
Commissioners present: Amber Gove (ANC 6A Chair, 6A04), Keya Chatterjee (6A01), Robb Dooling (6A06)

The agenda was amended to shift the Old Business item to the end of the meeting to accommodate the Florida Avenue NE Streetscape Project Outreach team participation.

- III. New Business.
 - A. District Department of Transportation (DDOT) updates on the Low-Impact Development pocket parks at the intersections of 8th Street NE/K Street NE/West Virginia Avenue NE and of 9th Street NE/L Street NE/West Virginia Avenue NE. [Jo-Elle Burgard](#), DDOT Landscape Architect, presented the current plans for both pocket parks, noting that the 8th Street NE/K Street NE/West Virginia Avenue NE park will be integrated with the K Street Bike Lane Extension. The construction task order for these parks is waiting to be signed and includes eight total sites throughout the District. Installation for both pocket parks is expected in Spring 2024
 - i. TPS Committee Co-Chair Lynch asked why the crosswalk on the south side of the intersection of 8th and K Streets NE was being removed. Ms. Burgard responded that it is considered a “mid-block crossing” which DDOT is attempting to remove as part of safety efforts.
 - ii. Co-Chair Lynch asked if a crosswalk can be installed at the intersection of L Street NE and West Virginia Avenue NE, on either the north or south side of the intersection as pedestrians regularly cross West Virginia Avenue NE at that location while walking down L Street NE. Ms. Burgard responded that she will inquire about such an addition with the project team.
 - iii. Co-Chair Lynch asked about the installation schedule. Ms. Burgard responded that she has a construction task order waiting to be signed that includes eight other sites throughout the District. She is expecting installation for both pocket parks in Spring 2024.
 - iv. TPS Committee Member Sussman asked if a Notice of Intent (NOI) would be released for this project. Ms. Burgard responded that since no parking would be impacted, there will be no NOI. Parking-related impacts on K St are being rolled into the K Street Bike Lane Extension NOI.
 - B. [NOI-23-161-PSD](#): K Street Bike Lane Extension. [Mike Goodno](#), DDOT Bicycle Program Specialist, presented plans for the extension of bike lanes on K Street NE from 6th to 8th Streets NE (with a focus on the 700-block of K Street NE, which is in 6A01). The plans are intended to fill the gap between existing bike lane infrastructure on K Street NE (ending at 6th Street NE) and West Virginia Avenue NE.
 - i. Commissioner Chatterjee thanked Mr. Goodno and DDOT for planning to close the gap in this network and requested removal of the left turn lane on K Street NE. Mr. Goodno responded that K Street is a minor arterial but does appreciate the safety concerns and will take the comment back to DDOT traffic engineers.

- ii. Commissioner Dooling noted that we want to view “traffic” as not just vehicles, but also as cyclists and pedestrians traveling through the area.
- iii. TPS Committee Member Sussman asked if it was possible to add flex posts to the bike lanes at the corner intersections due to so many examples of vehicles parking in those areas for ten to 20 minutes at time, blocking the bike lanes. Mr. Goodno acknowledged the problems, particularly on New Jersey Avenue, but said that maintenance is the biggest challenge that DDOT has to deal with.
- iv. Community Member Tom Ulan (600-block of K Street NE, 6C01) asked if the residents of 6th St were consulted about the proposed bike lane installation, and asked why other streets were not considered when K Street is so busy. Mr. Goodno responded that the NOI process is the formal notification process, and that DDOT does try to conduct additional outreach through the ANCs. As for the selection of K Street, Mr. Goodno noted that K Street is the only street that connects all the way through [beyond North Capitol Street]. Additionally, Mr. Goodno referenced the 2018 [NoMa / Mount Vernon Triangle Bicycle Network Study](#) that identified K St as the best alternative between 7th and 7th Streets NW.
- v. Community Members Katie and Matthias Corrotte live on the former West Virginia Avenue block that is becoming the pocket part. Kaite does not mind losing a parking space, but wanted to know if it is possible to have a Pick-Up/ Drop-Off (PUDO) area for mail/grocery delivery and if service vehicles will be able to access their block. Mr. Goodno responded that they can adjust the curbside uses (such as adding PUDOs), and that the unprotected bike lanes planned for K Street allow for service vehicle or moving truck usage. Mr. Corrotte expressed concern that removing parking spaces for three or four houses on this block that have no other access to their homes (no alley access) will be too isolating. He is also concerned about the intercity buses that turn left from West Virginia Avenue onto 8th Street and then immediately right onto K Street and noted a safety issue for cyclists riding that same route alongside the buses. Mr. Goodno noted there was no parking along this part of the block prior to the pocket park, but Katie responded that there had been a few parking spots on the south side of K Street that were removed sometime during the pandemic.
- vi. Commissioner Chatterjee reiterated Mr. Corrotte’s point about the buses and large trucks not being able to make the turn from West Virginia Avenue through to K Street, and asked if there was a way to direct truck traffic along a different route. Mr. Goodno responded that they’d have to look at what the designated truck route is but given K Street’s designation as a minor arterial that was unlikely. He added that perhaps making the 800 block of West Virginia Avenue a one-way would help reduce that traffic.
- vii. Commissioner Dooling asked if it is possible to get raised crosswalks around J.O. Wilson Elementary School (600-block K Street NE). Mr. Goodno said he could bring the question back to the DDOT engineers, but because K Street is a minor arterial, raised crosswalks are not normally applied (though there are some exceptions).
- viii. Community Member Helen Ulan asked if the DDOT engineers have observed the traffic flow during the school day pick-up and drop-off times, when it becomes very congested with some drivers even stopping in the vehicle traffic lane to walk their children into the school. She also expressed concern for a wheelchair-bound neighbor on the 600-block of K Street NE who had applied for a handicapped parking spot in front her house but was instead offered a spot a block away due to the bike lane plans. Mr. Goodno responded that he is unaware whether or not the DDOT engineers have been out during school hours, but they have been out for a number of issues, and that perhaps better traffic enforcement would help or DDOT could look at modifications to the curbside. As for ADA accessibility, Mr. Goodno noted this issue on other projects, and it’s a balance they have to find. DDOT

is not required to provide a parking spot right in front of the house, but just as close as possible, and that is what happened in this case.

- ix. DC Resident, Nicholas DelleDonne (Dupont East Civic Action Association), asked if Mr. Goodno had made a similar presentation to ANC 6C, and how DDOT decides between the safety of a bike lane over the safety of a curb bulb out (which would be removed from plans at K and 8th Streets). He also expressed an overall concern that the bike lanes are not improving safety. Mr. Goodno responded that he has not presented to ANC 6C, but that he believes their Transportation Committee and Commission have both discussed it, and he is certainly willing to do so. Mr. Goodno referenced DDOT's long-range transportation plan, [MoveDC](#), that looks at the next 25 years for all modes of transportation, and that they are launching a 5-year plan for bike lanes as a part of it to protect among the most vulnerable users of DC transportation network. As for the bulb out, they are typically installed to reduce the crossing distance for pedestrians, but DDOT views the bike lanes as also narrowing the roadway as a benefit to pedestrians in the same location.
- x. Commissioner Christy Kwan (ANC 6C01) commented that ANC 6C did not take up this NOI when comments were originally due on August 31, 2023 because that was during their summer recess, but they have supported bike lanes along the K Street NE corridor back to 2017. She believes it is unconscionable for us not to do more to reduce traffic speed through this corridor.
- xi. Community Member Ms. Lewis asked why the bike lane users are being prioritized over the actual residents of these two blocks. She further asked how Mr. Goodno and DDOT resolve the issue that the actual residents on these blocks overwhelmingly articulate harm and disapproval and base your decisions on the opinions of the ANC who ignore those concerns. Also, why is a straight through such a priority when bikes are flexible? Mr. Goodno responded that considering residents versus travelers is a delicate balance. Roadways are a public right of way for both people who live there and who need to get through the area. DDOT believes that building the bike infrastructure will get more people out of their cars, slow traffic down, and reduce overall traffic to improve safety. Mr. Goodno noted that DDOT takes community comment very seriously, but they are also directed to give "great weight" to the ANCs who are elected by the community. Ms. Lewis followed up that, while DDOT is encouraging people to bike, not everyone has the convenience of being able to bike, and that should be taken into consideration. She also asked if Mr. Goodno could verify if the K Street Transitway is under review or halted because many of these plans reference back to the K Street Transitway, which was for K Street NW. Mr. Goodno believes that the K Street Transitway is on hold for now because construction was not funded, though some funds were available for the design. Bike lanes on K Street have been in plans since 2005.

Commissioner Chatterjee made the motion recommending: That ANC 6A send a letter of support to DDOT for [Notice # 23-161-PSD - K St NE Bike Lane Extension](#) with the following additional requests: that DDOT consider removing the turn lanes in support of reducing vehicle speed; that DDOT explore options for pickup and drop-off areas on the 700-block of K Street NE; that DDOT review the turn radius at the intersection of 8th and K Streets NE; and that DDOT consider installing flex posts at intersections along the south side of K Street NE to prevent blockages.

Commissioner Dooling seconded the motion. The motion passed 7-0-1, with Commissioners Gove, Chatterjee and Dooling, and TPS Committee Members Lynch, Sussman and Angelone voting in favor, and TPS Committee Member Fletcher abstaining.

- C. TPS Committee draft inputs to the ANC 6A Annual Report. TPS Committee Co-Chair Lynch presented the TPS Committee draft inputs to the ANC 6A Annual Report. Committee Member Sussman recommended that, going forward, the Committee create a working document to continually update TPS Committee inputs to future ANC 6A Annual Reports throughout the year to limit a significant workload at the end of the year.

TPS Committee Co-Chair Lynch made the motion recommending: That the ANC 6A TPS Committee approve TPS Committee inputs to the ANC 6A FY23 Annual Report, and forward to the Commission. **TPS Committee Member Sussman seconded the motion. The motion passed unanimously, with all Commissioners and TPS Committee Members present voting in favor.**

IV. Old Business.

- A. DDOT update on the [Florida Avenue NE Streetscape Project](#). Mr. Peyton Manning of the Florida Avenue NE Streetscape Project Outreach Team updated the Committee and community on progress on the Florida Ave NE Streetscape Project. The Project is still on schedule for completion by October 2024, and the segment between 2nd and 6th Streets NE will be substantially completed by Thanksgiving this year. Washington Gas is currently working between 9th and 14th Streets NE and should be complete with all work by the end of December 2023.
- i. Co-Chair Lynch asked about the delays to the sidewalk construction from M Street NE to 7th Street NE. Mr. Manning responded that the team is awaiting coordination on some issues with DC Water along that block. There are DC Water tie-ins below ground (such as with the bioretention areas).
 - ii. Commissioner Chatterjee noted that she and Co-Chair Lynch met with DDOT at the intersection of 12th and K Streets NE regarding light signalization. Adjusting the signals could improve safety there, particularly around all of this construction. The DDOT signal team was planning to get back to us with recommendations within a week, and the Committee will update the Florida Avenue NE Streetscape Project team in November with their feedback.

V. Community Comment. None.

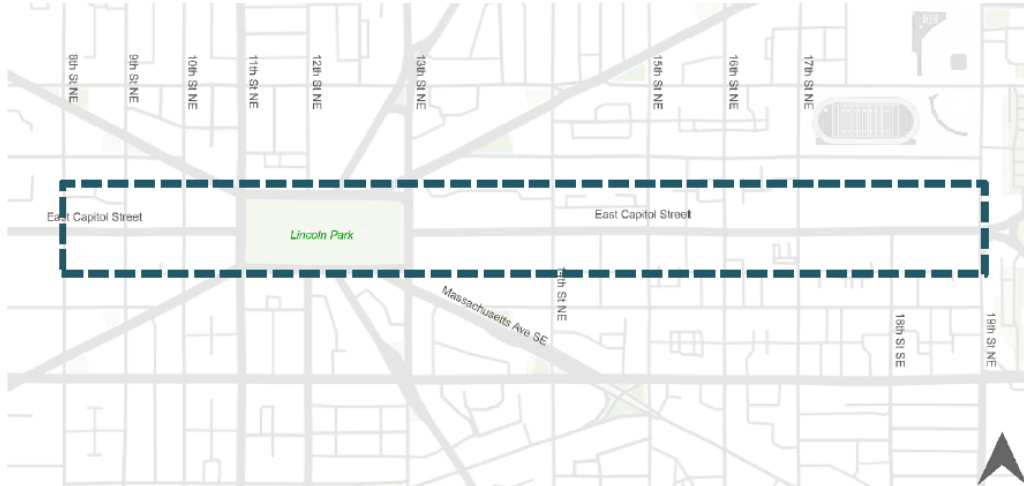


Figure 1: East Capitol Street Corridor Subject to Speed Limit Change

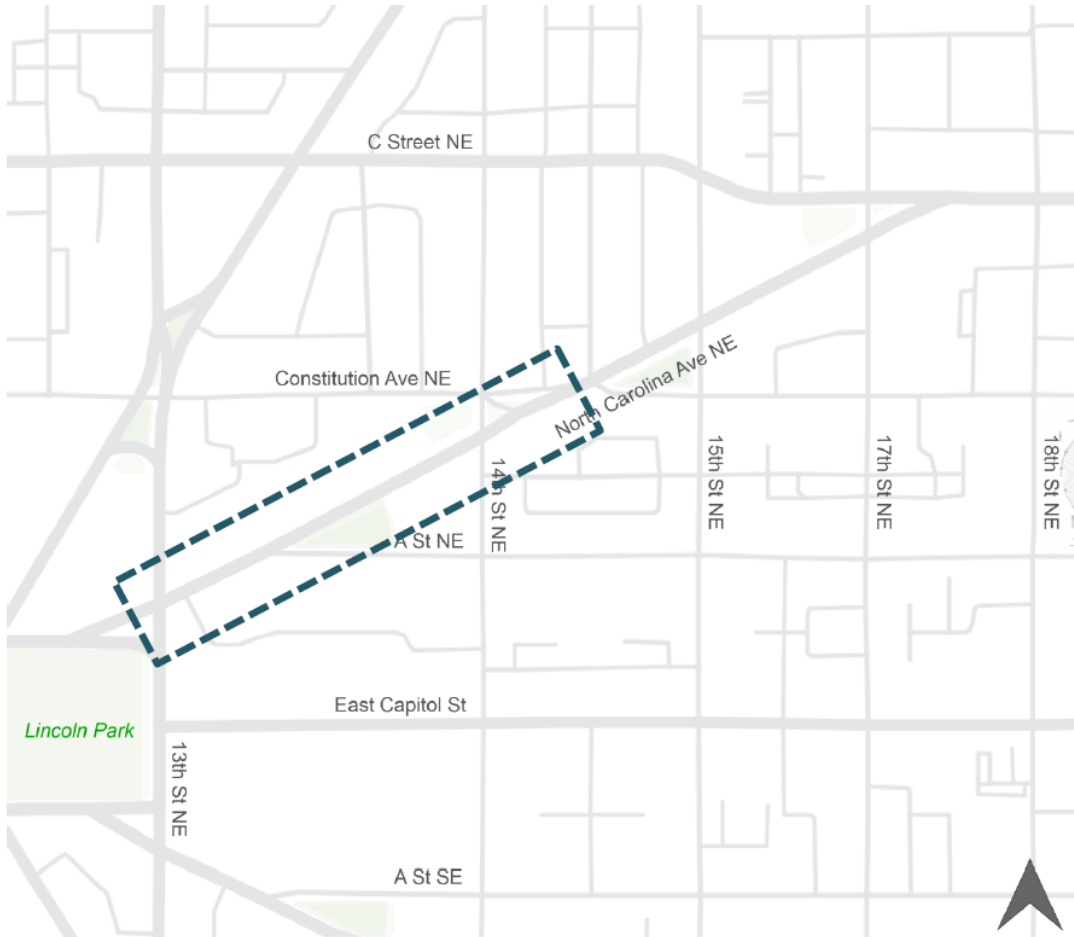


Figure 1: North Carolina Avenue NE Corridor Subject to Speed Limit Change

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Reduction of speed limit on 8th Street NE between Florida Avenue and East Capitol Street from 25 mph to 20 mph**

DDOT determined that the speed limit on this segment of 8th Street NE should be reduced to 20 mph based on federal guidelines and an analysis of traffic volumes, traffic speed data, crash history, and roadway context.

Figure 1 shows the location and extent of the proposed speed limit change.

All comments on this subject matter must be filed in writing by **December 6, 2023** (thirty days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and anticipates initiating implementation of the above-mentioned modifications starting at the end of the thirty business days, pending weather conditions.

Introductions of Committee Members and Commissioners

Previously Heard Cases

There was no discussion of previously heard cases.

Old Business

1. Annual Report of Activities: Discuss requirement to submit a summary of the economic development and zoning activities for the year. Designate a writer to draft the Committee contributions.

The Committee members discussed the generation of the annual report. A draft document was created and reviewed by the Committee. Mr. Cushman recommended the highlights of the major accomplishments be accompanied by dates for ease of reference. Mr. Cushman recommended we highlight our success in negotiating with the developer of 1000-1016 H Street NE. The Committee decided to add paragraphs to the report highlighting EDZ's review of the Slutty Vegan restaurant on H Street, and support for Sasha Bruce Youthworks.

Mr. Greenfield moved that the EDZ revise the draft and submit it to the full ANC. Mr. Cushman seconded the motion. The motion passed unanimously, with five votes in favor and none opposed.

New Business

2. 650 H Street NE (BZA #20990): Request for Special Exception relief pursuant to Subtitle H § 1202 and Subtitle X § 901.2 from the matter-of-right uses of Subtitle H § 1103 to permit a financial services use on the ground floor of an existing, six-story, mixed use building in the NMU-5A/H-H (formerly NC-10) zone.

Jon Lastuvka from Rock Creep Properties presented the project. Mr. Lastuvka noted that the project is actually in ANC 6C, but it is adjacent to ANC 6A, and they are seeking our support as well. The development was approved in 2015/2016, and construction completed in February 2020. Mr. Lastuvka noted that financial services is a matter of right use, but the plan is that the financial services company would exceed 20% of the ground floor, which requires a special exception. Mr. Lastuvka described other commercial businesses that they have discussed becoming tenants for the property. Since there are residences above, Rock Creek is not interested in a tenant that is a restaurant. Mr. Lastuvka said that the financial services business would be a bank and would not be a check cashing company.

Questions from the Committee included what type of financial services company was being targeted.

Mr. Greenfield moved that the EDZ recommend that ANC 6A support the request for relief. Mr. Cushman seconded the motion. The motion passed unanimously, with five votes in favor and none opposed.

3. 106 13th Street SE (BZA #20996): Request for Use Variance Relief pursuant to Subtitle X § 1002 from the matter-of-right uses of Subtitle U § 301 to expand an existing restaurant use to the second floor, of a semi-detached, two-story with basement, commercial building in the RF-1 zone.

Mr. Martin Sullivan presented the project. He noted that the property is located in ANC 6B. It had previously gone before the BZA, and they had granted relief to allow use as a restaurant on the ground floor and cellar but refused to allow restaurant use on the second floor. Mr. Sullivan noted that restaurant (Pacci) is very popular, and the existing size is not large enough to make it profitable.

Speaking in favor of the request for relief was Ziad Demian, an architect and local resident. Mr. Demian described how, as a resident, he enjoyed the restaurant, but the lack of space makes it difficult to enjoy. As an architect, Mr. Demian noted that it is very difficult to use the second floor space for anything but a restaurant.

Commissioner Chander Jayaraman from ANC 6B attended the meeting and spoke in favor of the request for relief. He noted that Pacci is an amenity that residents of the neighborhood enjoy, and Pacci has a very positive relationship with the community. He noted that it would help the request if ANC 6A and 6B had a united front in favor of the establishment.

Commissioner Gove noted her support for the request, and how much community support for Pacci's she saw as she discussed this with community members. Mr. Cushman noted that when this project originally came up, he was opposed but has since that time he has enjoyed the restaurant and considers it an amenity of the neighborhood. The previous restaurant owner was poorly run, and the current owner has resolved any problem.

Questions from the Committee included the status of the vestibule that was put out for a while, if there would be outdoor seating, why the owner did not seek to rezone the property, if there would be any construction, whether there was any use of the second floor currently, letters of support from the community and the size of the restaurant (in seats).

Mr. Greenfield moved that the EDZ recommend that ANC 6A support the request for relief. Mr. Mendonsa seconded the motion. The motion passed unanimously, with five votes in favor and none opposed.

Mr. Greenfield announced after the meeting that he will be stepping down from the EDZ after this year.

Economic Development and Zoning (EDZ)

Meetings and Attendance

During FY 2023, ANC 6A EDZ Committee held nine regularly scheduled public meetings, generally on the third Wednesday of each month, except for holidays and the month of August. All meetings were conducted virtually on Zoom, began at 7:00pm, were properly noticed, and were open to the public for comments and questions.

FY 2023 ANC 6A EDZ Committee Meetings took place in October and November 2022 as well as January, February, March, April, June, July, and September 2023.

ANC 6A EDZ-Related Actions from January 2022 to October 2023

January 2022: ANC 6A expressed its concerns about the situation facing the tenants at the Havana Building at 1219 K Street NE. In this case, the landlord was extremely derelict, and allowed the building to become a public safety concern both for the residents, and the surrounding community. This building is 100% occupied by residents who use D.C. vouchers. While the Havana was an extraordinary case of dereliction of the responsibilities of a landlord, it also highlighted some of the deficiencies in the existing voucher system and oversight of landlords who house low-income residents who receive assistance from the D.C. government.

November 2022: ANC 6A held discussions about expanding the arts use on H Street and expressed support for the Green New Deal for Housing Act. EDZ also held extensive discussions and hearings about the introduction of a new Racial Equity Tool from BZA. EDZ had training from the Office of the Attorney General on its use and how we should apply it to ANC 6A. We leveraged this tool as part of the review of 721 H Street.

December 2022: ANC 6A supported the request for zoning relief for 1717 E Street NE. The developer sought extensive relief, including area variances. The need for extensive zoning relief was caused by the existence of a large, antiquated sewage pipe directly under the property, which DC Water had an easement for. This easement caused an extraordinary situation that warranted the relief, in the view of the ANC.

December 2022: ANC 6A supported the special exception request for the Sasha Bruce Youthworks. This facility provides necessary services to our city and community, and ANC 6A strongly supported their efforts. As part of the ANC's support, a community advisory council was established to help with interactions between the facility and the community.

March–April 2023: ANC 6A conducted extensive reviews and discussions with the developer of a project at 1000–1016 H Street NE. This was proposed as an 80-unit building, with no ground floor retail, despite it being the standard for other buildings on H Street. Several meetings were held on the matter. The developer eventually added a small amount of ground floor retail, and the ANC supported, although it was far from enthusiastic support due to the relatively small amount of ground floor retail. The negotiations improved the project and how it serves the community through the increase of ground floor retail, which will active that neighborhood more than just residential units would.



New Business



April 2022 and July 2023: A much more collaborative and positive interaction was involved in ANC 6A’s review of the project at 1207 H Street (AutoZone). The developer in this case took pains to consult with the ANC and the community extensively throughout the process and updated the design in a number of ways to address community concerns. The developer, Mr. Chris Miller, is to be commended for outreach and collaboration on this development, and his approach should be an example to other developers on how to engage an ANC and a community.

September 2023: ANC 6A supported the special exception request for the Slutty Vegan restaurant that is being established on H Street at 1244/1246 H Street, NE. As a new fast-food establishment, zoning requires the community to review establishments, and ANC 6A held extensive discussions to ensure there would be no negative impacts on the community.

Accomplishments

Sidewalk Survey

ANC 6A co-sponsored a sidewalk survey with ANC 6B, ANC 6C, and Capitol Hill Village. The results are summarized below.

- 473 households responded to the sidewalk survey.
- 305 respondents reported that they or a member of their household fell in the community **over the past two years** – many experienced **multiple falls**.
- **Poorly maintained brick sidewalks** were cited as problems more than 180 times.
- 263 injuries were reported.
- These falls resulted in **114 medical care service encounters**.
- 105 people who fell were **younger than age 40**.
