Mr. Fierberg:

At our regularly scheduled and properly noticed public meeting on October 14, 2004, with a quorum present, the Commission voted to provide additional flexibility to negotiate individual agreements with the establishments on H Street to include revisions to the existing ANC 6A Cooperative Agreement for Class A and Class B Liquor Licenses.

To facilitate timely response and input to the individual protest mediations, the Commission designated Commissioner Alberti and Commissioner Ward to represent the Commission during these continuing negotiations. Assuming that these negotiations produce tentative agreements that are approved by Commissioner Alberti and Commissioner Ward, the Commission will formally consider the adoption of these agreements at the next regularly scheduled Commission meeting on November 11, 2004. If the circumstances warrant, the Commission is prepared to hold a special meeting, in accordance our Commission Bylaws and District of Columbia laws and regulations, to consider the adoption of these agreements prior to the November Commission meeting.
