#### Greetings,

We had a good turn out last night (Thursday, February 10, 2005) at Miner Elementary School to discuss the alley behind Auto Zone. Our Neighborhood Services Coordinator, Mr. Peter Jones, is proposing to use a Multiple Agency Work Plan (MAP) to address many of the long standing challenges we have been facing. I am attaching a file that catalogs those problems as well as provides the key e-mails that list recent actions to bring us where we are today.

First, what is a MAP? A MAP is used when the city want to concentrate on a hot spot area. It brings all the required agencies and resources of the city to focus in on a very specific, defined area. The MAP Peter is proposing runs from 12<sup>th</sup> Street to 14<sup>th</sup> Street and from I Street to G Street. This would include Linden Place, Wylie Street and the H Street Entertainment corridor.

Second, Peter proposed issues/problems the MAP will work on are as follows: criminal activity, illegal dumping, consistent removal of trash, secure vacant properties, enforce action on abatement of vacant properties and non-payment of tax liens, reduce rodent population, maintain tree boxes and eliminate illegal auto repair.

Third, Peter is looking for input on the issues/problems in the attached file. Please provide him your input by Thursday, February 17, 2005. Fourth, last night Peter stated the tentative launch date for the Wylie/Linden MAP is March 1, 2005. To be fair to Peter, he hasn't had the opportunity to get confirmation with the other agencies listed, so that may slip. But, the good news is that help is coming sooner rather than later.

A few other issues were highlighted last night:

One, new brick sidewalks on Linden Place. Peter stated that it is expensive (with a sigh). However, DDOT will be working on H Street in the near future. Similar Barracks Row, if they work on a main street, the sometimes take care of the immediate side streets. Clearly, we have some safety issues on Linden regarding bulging sidewalks due to tree roots. Mr. Christopher Delfs from DDOT stated he would check into how we can potentially solve this problem.

Two, Community Public Gardens on abandoned property on H Street. Peter said this is not his lane, but we could check on who owns the property, If the city does, than this may be easier than we expect. Richard Luna, I didn't write down the addresses, can you provide them to me?

Three, there is constant standing water in the alley. We suspect that it is do the grading or slope of the alley in relation to the drains. Christopher said he would also look into this as well.

Four, using MPD cameras as a tool to deter illegal activity in the alley. As I stated at the meeting last night, it is one of many tools that can be used. I am not advocating the use of cameras. However, to see if this is a viable option, this is the approach I propose:

(1) the residents on Linden would have to agree that they would want a MPD camera installed in the alley. Discussion last night from those that attended the meeting indicated that depending on how "narrow" the camera's focus is (example, not recording backyards or personal property), there may be some interest.

- (2) accordingly, I will find out if a camera can be that narrowly targeted (example, just view the illegal dumping areas and not people's back yards). Also, there are different types live, continuous feed or just a recording that can be used later for playback. Again, I have more to learn here.
- (3) based on the information from point two, I will bring that information back to the residents on Linden Place. Let's tentatively schedule a meeting for March 10 at 6:00pm at Miner Elementary to discuss this very issue as well as get a general update on the MAP.
- (4) only if there is a consensus among the Linden Place residents on the use of a camera, then I would begin the formal process of requesting a camera. Even if the residents of Linden Place agree that cameras are acceptable, it is by no means assured they will be used. I also understand there are many hurdles to overcome. Again, another chance for me to learn more...

In close, Peter Jones has come up with a good plan to help us. I will provide an update once we have the consolidated input from everyone – around February 18, 2005. Commissioners Borbely and Holden, I am including you as the use of a MAP transcends the boundaries of my Single Member District. Please feel free to give me a call if you have any questions.




