Metro is working to improve the service quality and reliability of Metrobus services within the region. The **Service Evaluation Study** was initiated to identify the strategic needs for the following routes operating in the Washington, DC area:

- Sibley Hospital – Stadium Armory Line D1, D3, D6
- Glover Park – Dupont Circle Line D2
- Ivy City – Union Station Line D4
- MacArthur Blvd – Georgetown Line D5
- Hospital Center Line D8


