### **RE:** Fast-Tracking Vision Zero Roadway Safety Projects

Advisory Neighborhood Commissions:

I am writing to inform you about DDOT's new administrative processes to fast-track Vision Zero safety improvements to District roadways and sidewalks. An internal agency reorganization has placed all safety programs, including Vision Zero, under a single division, the Project Delivery Administration. This consolidation of safety efforts will enable DDOT to have a more direct impact on safety needs citywide.

In conducting this reorganization, DDOT analyzed timelines for the implementation of roadway safety improvements and found the community engagement process represents the greatest single time requirement in delivering safer streets. As a result, DDOT's efforts to implement safety improvements can extend over many months – and in some instances, years – due to a protracted and drawn-out process.

Effective November 1, DDOT is implementing the following administrative reforms to allow us to move faster in addressing traffic safety issues and more aggressively pursue the District's Vision Zero goals:

- 1. Discontinue revisions to projects after the completion of any required community engagement processes in accordance with District law or regulations;
- 2. Reduce the comment period for safety-related improvements;
- 3. Only issue Notices of Intent as required by the Administrative Procedure Amendment Act of 2000 (D.C. Law 13-249) to modify traffic and/or parking requirements (*e.g.*, new traffic control devices such as traffic signals/all-way stop control, changes to one-way restrictions, or removal of parking spaces); and
- 4. Discontinue requiring supporting documents from the ANC and community for traffic safety investigation requests.

As part of these streamlining efforts, we will strongly encourage community and neighborhood organizations to go through their ANCs with any roadway safety improvement recommendations. By eliminating and streamlining bureaucratic processes, DDOT will be able to move faster to improve the safety of our roadways. We must do all we can to better ensure the safety of our roadway users, especially our most vulnerable residents.

# **Safe Return to Running Guidelines**

The Ready to Rock: <u>Safe Return to Running Guidelines</u> will empower everyone involved to focus on a safe return to running. These guidelines outline measures we will be taking to reduce risk for participants, volunteers, our team and communities. With attention to density reduction, touchpoint minimization, enhanced hygiene, screening and education, as well as self-awareness, we will continue to deliver to you a rockin' participant experience with necessary adjustments so that participants can race safely, race smart, race their best.

### Enhanced Hygiene

- Hand sanitizer, hand washing stations and disinfectant wipes will be readily available around our event venues. Cleaning of common venue areas will be enhanced.
- Staff and volunteers will be provided with face coverings, and are required to wear the face covering properly at all times around the event venue. Disposable gloves will be used in applicable areas.
- Participants will be provided with face coverings at packet pick-up, and participants are required to wear a face covering properly around our
  event venues, including the start corrals and finish line areas. Find the World Health Organization (WHO) instructional video on how to properly
  wear a mask..

### Screening & Education


- We are providing training for staff and volunteers in appropriate personal health, personal hygiene, and safe support in necessary functional areas.
- We will provide Volunteer Smart™ guidelines for event volunteers.
- Participants, staff, and volunteers will be required to respond to a pre-event health questionnaire.
- We will in many venues institute no-touch body temperature screening. Individuals with a body temperature greater than 100.4° Fahrenheit, or 38° Celsius will not be allowed to participate, volunteer or work.

## • Touchpoint Minimization


- We will be reducing or removing touchpoints and points of interaction between staff, participants, and volunteers without compromising event safety and security.
- We have redesigned and reimagined areas such as packet pick-up, expo, merchandise, and finish line to minimize person-to-person contact.
- Aid stations will be reconfigured with more space to minimize both participant-to volunteer and participant-to-participant touchpoints.

# Density Reduction

- We will institute measures to increase space for participants and supporting personnel in areas such as expo, packet pickup and finish line.
- Alternative start configurations may be implemented to reduce the number of participants waiting in an enclosed area and to optimize distancing opportunities.
- Modification or elimination of non-essential race services and functions, such as expo and merchandise may also occur.
- The most significant element in course density reduction is being able to extend the duration of the start line program.

certified by the Chief Financial Officer.

251	an approved budget and financial plan and provide notice to the Budget Director of the Council

253	(c)(1) The Budget Director shall cause the notice of the certification to be published in

255	(2) The date of publication of the notice of the certification shall not affect the
256	applicability of this act.
257	Sec. 5. Fiscal impact statement.

261	Sec. 6. Effective date.
262	This act shall take effect following approval by the Mayor (or in the event of veto by the
263	Mayor, action by the Council to override the veto), a 30-day period of congressional review as
264	provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
265	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
266	Columbia Register.
